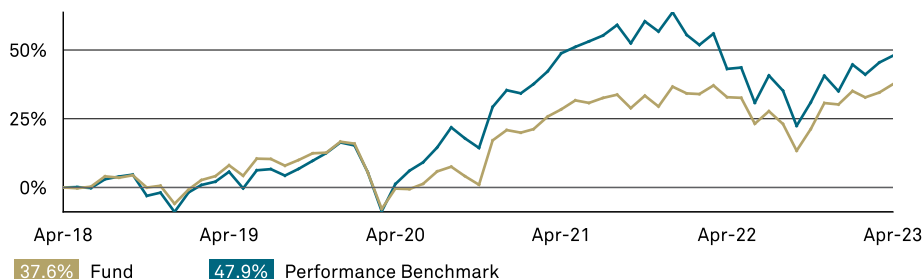

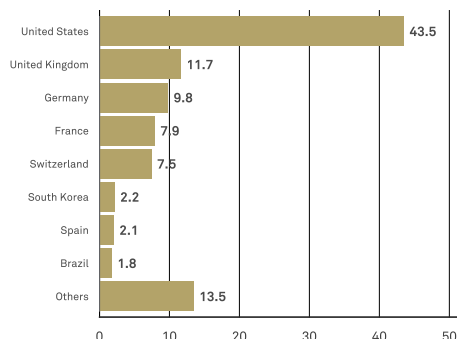

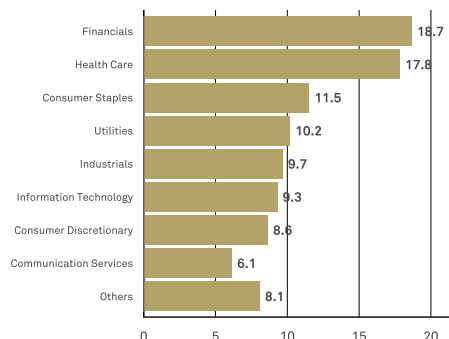

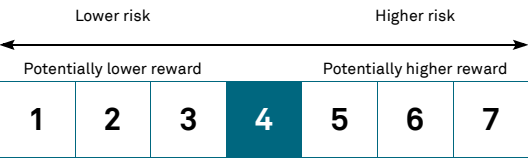

KEY RISKS ASSOCIATED WITH THIS FUND
