Objectives and Investment Policy

The Fund seeks to increase the value of its assets over the medium term by investing in EUR denominated shares issued by European companies, with a solid financial structure and/or potential for earnings growth.

After hedging, the sub-fund's exposure to currencies other than EUR will not exceed 5%.

It is actively managed and as such may invest in securities that are not included in the index which is MSCI EMU (NR).

Income are systematically reinvested.


