Objectives and investment policy

The Fund is actively managed. The benchmark 50% JPM GBI-EM Global Diversified (RI) + 50% JPM EMBI Global Diversified (RI) is used for performance comparison only. The Fund is not benchmark constrained and its performance may deviate significantly from that of the benchmark. The Fund seeks to increase the value of its assets over the medium term by investing in bonds and other debt instruments issued by emerging countries or companies from emerging countries, or operating in these countries, with a solid financial structure and/or potential for earnings growth.


The Fund may be invested into debt securities traded on the China Interbank Bond market.

Incomes are systematically reinvested.

Risk and reward profile

- Why is the Fund in this specific category?
- The risk category is justified by the investment mainly in Interest Rate instruments. The investor's attention is drawn to the fact that an increase in interest rates results in a decrease in the value of investments in bonds and debt instruments and more generally fixed income instruments.
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- <u>Credit Risk:</u> This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- <u>Liquidity Risk</u>: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
- Risk related to investments in Mainland China: such investments are subject to additional risks that may be the result of political, economic, social, tax, market and operational factors specific to the Chinese Market.


