The Product seeks to increase the value of its assets over the medium term by investing in shares issued worldwide by companies which innovate or benefit from innovating technologies including but not limited to artificial intelligence, cloud computing, and robotics.

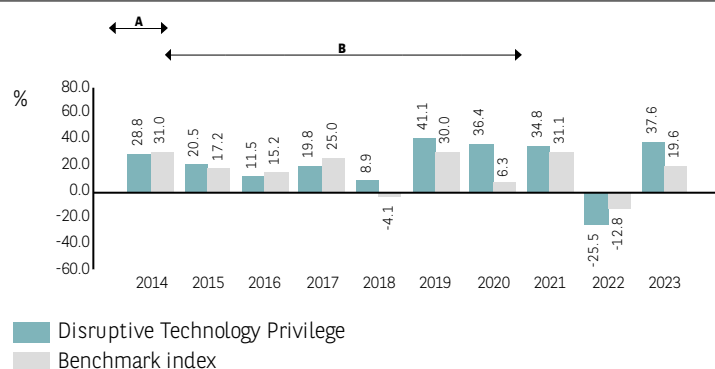
This figure may vary from year to year. It excludes:
