# LarrainVial Asset Management SICAV - Latin American Equity Fund - Class A

(ISIN: LU0939495528) Latin American Equity Fund (the 'Fund') is a Sub-Fund of LarrainVial Asset Management SICAV (the 'Company'). Lemanik Asset Management S.A. is the Management Company (the 'Management Company') to the Fund.

#### **Objectives and Investment Policy**

- The Fund aims to provide Investors with an appreciation of their capital by investing in Latin American companies.
- The Fund will invest at least 70% in Latin American companies or companies which conduct the main part of their economic activity within the region. The Fund will invest directly in stocks and similar securities. Temporarily the Fund may also invest in cash equivalents or bonds.
- Loans and short-selling are not allowed. The first five holdings should not represent more than 40% of the portfolio.
- The Fund is active and managed with reference to the benchmark "MSCI EM 10/40 Latin America". The Investment Manager has discretion over the composition of its

The ongoing charges figure is based on expenses for the year ending 31 December 2021.


