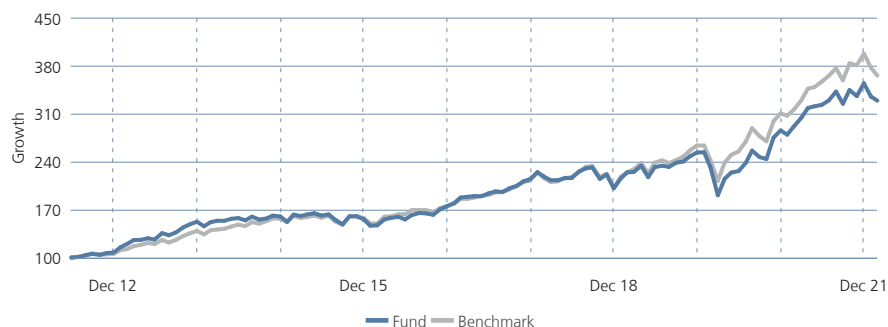

## RISK CONSIDERATIONS
