



Maturity Breakdown (%)





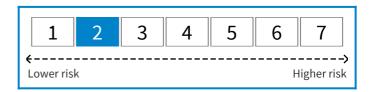
