

# **Risk considerations**

Counterparty risk: The fund may have contractual agreements with counterparties. If a counterparty is unable to fulfil their obligations, the sum that they owe to the fund may be lost in part or in whole.









On 19.02.2024 Richard Sennitt, Scott Thomson, Ghokhulan Manickavasagar, Jeegar Jagani replaced Richard Sennitt, Scott Thomson, Ghokhulan Manickavasagar, Jeegar Jagani & Mike Hodgson as fund managers. On 28.03.2015, the index changed from MSCI AC Pacific ex Japan Net TR (converted in EUR) to MSCI AC Pacific ex Japan Net TR EUR Hedged. The full track record of the previous benchmark has been removed and replaced with the new one.

#### Benchmarks: (If applicable)

Some performance differences between the fund and the benchmark may arise because the fund performance is calculated at a different valuation point from the benchmark. The fund is not managed with reference to a benchmark. The comparator benchmark has been selected because the investment manager believes that the benchmark is a suitable comparison for performance purposes given the fund's investment objective and policy.

# Source and ratings information

**Impact scores:** These are generated using Schroders' proprietary tool SustainEx<sup>™</sup>.
