Objectives and investment policy

The Fund seeks to grow capital and generate income by investing primarily in Emerging countries corporate bonds.


The Fund is actively managed and invests in relatively high-quality bonds with a minimum credit rating of BBB- (S&P or Fitch) or Baa3 (Moody's). As an exception to this rule, the Fund may invest up to 15% of its net assets

As an exception to this rule, the rund may invest up to 15% of its net assets in non-rated products/issuers.

The Fund will invest at least 80% in the currencies of OECD countries. The currency risk against USD will be largely hedged.

The Fund uses the JP Morgan CEMBI Diversified Investment Grade Index (the "Benchmark") for performance objective. The Benchmark is representative of the investment universe and of the risk profile of the Fund although the Investment Manager has significant discretion to deviate from its securities and weighting.

Risk and reward profile
