Payden USD Low Duration Credit Fund (the “Fund”)

Payden US Dollar Class (Accumulating) (ISIN:IE00BD1NVL60)

The Fund is a sub-fund of Payden Global Funds public limited company (the “Company”)

Objectives and investment policy

The investment objective of the Fund is to seek to maximize total return by investing primarily in a portfolio of corporate debt securities, both fixed and floating rate, denominated in US Dollars.

The investment manager will actively select, purchase and sell securities with the aim of meeting the investment objectives of the Fund. The relative duration of the Fund will generally be within +/- 2 years of the duration of the Barclays US 1-5 year Corporate Index.

Investments will include, but not be limited to, debt securities of U.S. and non-U.S. issuers. This may include issuers in emerging market countries up to a maximum of 20%.

Investments will be primarily denominated in US Dollars, however, investments may be denominated in other currencies, including emerging market currencies.

The Fund will invest primarily in investment grade debt securities issued by corporations but may also invest in debt securities issued by government agencies and supranationals.

The Fund may also invest in money-market securities and agency mortgage-backed securities.

The Fund may use derivatives with the aim of managing interest rate and currency risk more efficiently.

The Fund may also use derivatives for both hedging purposes and for taking investment positions. These may include short positions where the Fund seeks to benefit from the sale of an asset that it does not physically own.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 12 months.

Your shares are accumulating, meaning that income and gains of the Fund will be reinvested to increase the value of the Fund.

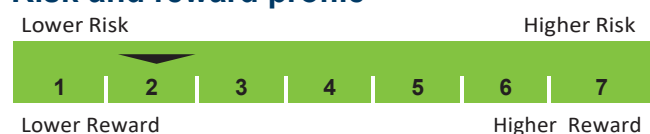
Your shares are denominated in US Dollars, the Fund’s base currency. Typically, assets held by the Fund which are denominated in a currency other than the base currency may be hedged or substantially hedged to the base currency.

Your shares can normally be bought and sold on any business day, being a day on which banks are open for business in Ireland, the UK and the US.

The Fund is actively managed with reference to the Bloomberg Barclays US Corporate Bond Index 1-5yr (the “Index”). The Index is used (i) as a universe from which to select or hold securities; and (ii) to measure performance of the Fund. The investment manager has discretion over the composition of the portfolio of the Fund and may select securities not included in the Index. However, in normal market circumstances, it is expected that a significant portion of the Fund’s constituents will also be Index constituents and deviations from the Index may be limited. Whilst the investment manager does not employ a defined strategy to align with a benchmark during periods of volatility, it will take account of market environment and perceived risks at any given time and will employ its investment discretion as described in the investment policy accordingly.

Risk and reward profile



The risk indicator was calculated using representative historic performance data and may not be a reliable indicator of the risk profile of the Fund.

The Fund is rated 2 because of the low level of risk due to the nature of its investments in debt instruments. The following risk factors may give rise to performance volatility and may expose the Fund to losses: (i) the value of the Fund will rise as bond yields generally fall but will fall in the event that bond yields generally rise; (ii) changes in the perceived credit worthiness of bond issuers will contribute to performance volatility.

A fall in credit worthiness will generally lead to a fall in the value of the Fund and vice versa; and (iii) while the assets held by the Fund which are denominated in a currency other than the base currency will be hedged back to the base currency, currency risks will not be totally eliminated.

Material risks not adequately captured by the risk indicator include:

Counterparty risk: The insolvency of any institutions providing services such as custody or acting as counterparty to any transaction may expose the Fund to financial loss, including counterparties to derivatives and foreign exchange trades.

Credit risk: An issuer may fail to repay income or capital in full, leading to a financial loss for the Fund.

Liquidity risk: There may be some circumstances in which the ability to sell certain assets at little cost will be impaired.

Derivative Risk: Gains and losses from the use of derivatives may be greater than where the underlying investment is purchased directly by the Fund.

Emerging Market Risk: Emerging economies may exhibit higher levels of investment risk.

Operational Risk: There may be risks associated with the safekeeping of the assets by the Depositary and sub-custodians.

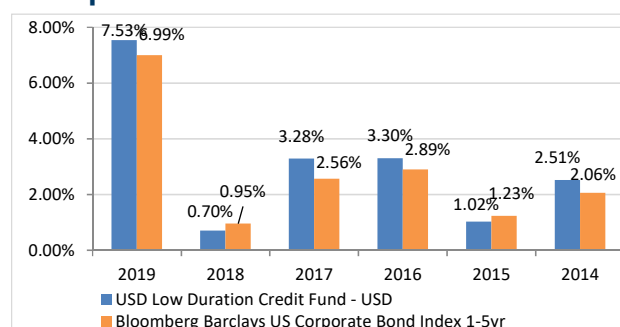
*Anti-Dilution Levy: An investor may be required to pay an Anti-Dilution Levy where there are net subscriptions or net redemptions of Shares on a particular Dealing Day by reducing the subscription monies paid in to the Fund or redemption monies paid out by the Fund as the case may be by the amount of the applicable Anti-Dilution Levy (ADL) to cover dealing costs and to preserve the value of the underlying assets of the Fund. ADL proceeds are credited to the Fund.
