#### Objectives and investment policy


This Fund is actively managed. The benchmark FTSE EPRA NAREIT Europe (25% UK Capped) 8/32 (NR) (Lux tax rate) is used for performance comparison only. The Fund is not benchmark constrained and its performance may deviate significantly from that of the benchmark.

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by European real estate companies, or companies that operate in the European real estate sector. The Fund does not invest in real estate directly.

Environmental, social and governance (ESG) criteria contribute to, but are not a determining factor in, the manager's decision making. Incomes are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus.

#### Risk and reward profile
