"Pound Sterling" Hedged Shares of Vanguard Japan Government Bond Index Fund (the "Fund"), a subfund of Vanguard Investment Series Plc (ISIN: IE00BFRTD946) The Fund is managed by Vanguard Group (Ireland) Limited ("VGIL"), part of the Vanguard group of companies.

Objectives and investment policy

Objective

The Fund seeks to provide returns consistent with the performance of the Barclays Global Aggregate Japan Government Float Adjusted Bond Index (the "Index").

Investment policy

- The Index includes investment-grade Japanese yen-denominated treasury and Japanese government related bonds with maturities greater than one year that pass screening for size and liquidity. Investment-grade bonds are bonds with a relatively low risk of default. Liquidity means the extent to which a bond may be bought and sold without significantly distorting its price. The Fund will normally maintain a weighted average maturity consistent with that of the Index, which ranges between 5 and 10 years.
- The Fund attempts to:


1. Sample the Index, meaning that it holds a range of bonds that, in aggregate, approximate the full Index in terms of key risk factors and other characteristics.

2. Remain fully invested and hold small amounts of cash except in extraordinary market, political or similar conditions where the Fund may temporarily depart from this investment policy.

- The Fund may invest in financial derivative instruments that could increase or reduce exposure to underlying assets and result in greater fluctuations of the Fund's net asset value. Some derivatives give rise to increased potential for loss where the Fund's counterparty defaults in meeting its payment obligations.
- The Fund invests in securities which are denominated in multiple currencies. The share class is hedged to reduce the risk of movement between the value of the share class currency and JPY.
- The Fund may not be appropriate for investors who plan to withdraw their money within 5 years.
- Income from the Fund will be reinvested and reflected in the price of shares in the Fund.
- Shares in the Fund can be sold on a daily basis (save on certain bank holidays or public holidays and subject to certain restrictions described in Appendix 1 of the Prospectus) by submitting an application in writing or by telephone before 16:00 (Irish time) on the business day prior to the relevant dealing day. The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.


