### **Objectives and Investment Policy**

The Fund seeks to increase the value of its assets over the medium term by investing in shares of small Japanese companies, and/or small companies operating in Japan.

It is actively managed and as such may invest in securities that are not included in the index which is 100% Russell Nomura Small Caps (RI) - 100% Cash Index JPY Interbank Rate 1 Month (RI) + 100% Cash Index EUR Interbank Rate 1 Month (RI).

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) unless the Tokyo Stock Exchange is closed. This share class aims at hedging its currency exchange risk against the Fund's portfolio exposure currency. However, the currency exchange risk cannot be completely neutralized as the hedging technique is based of the Fund's NAV.

• Why is the Fund in this specific category?

Subfunds investing in small capitalisation companies, are likely to be subject to a higher than average volatility due to a high degree of concentration, greater uncertainty because less information is available, there is less liquidity, or due to greater sensitivity to changes in market conditions (social, political and economic conditions).
