#### FUND OVERVIEW



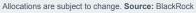


