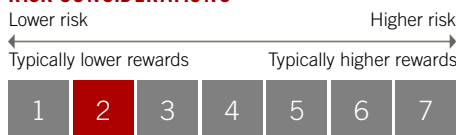
The charges you pay are used to pay the costs of running the Compartment, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

## INVESTMENT OBJECTIVE

The compartment mainly invests in corporate fixed income instruments of investment grade, denominated in euros, with a maturity less than or equal to six years. The average residual maturity of the portfolio must not exceed three years.

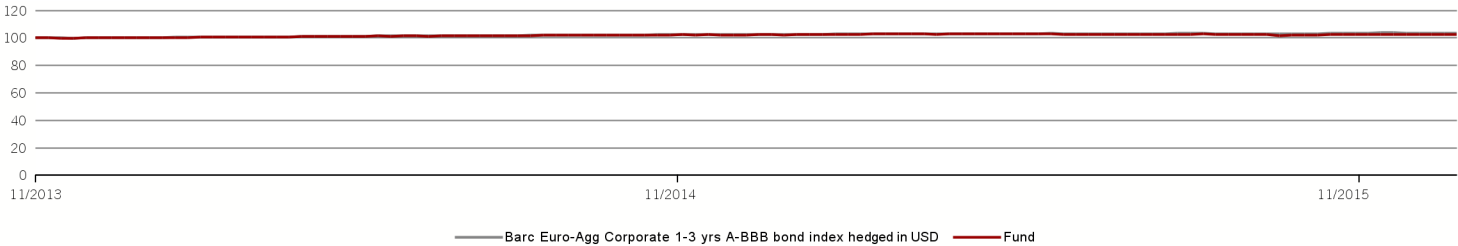

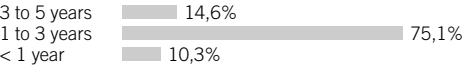

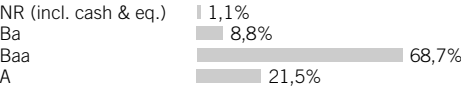
VALUE OF 100 USD INVESTED SINCE INCEPTION



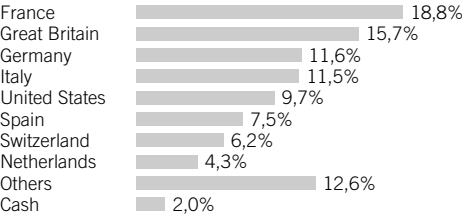
MATURITY PROFILE
