Risk considerations

Contingent convertible bonds: The fund may invest in contingent convertible bonds which are bonds that convert to shares if the bond issuer's financial health deteriorates. A reduction in the financial strength of the issuer may result in losses to the fund.







The full track record of the previous index has been kept and chain linked to the new one. Schroder ISF Strategic Credit was launched on 12.03.2014 to accommodate a transfer of shareholders from the Cazenove fund to the Schroder ISF SICAV Please note that the fund's benchmarks were changed on 21 June 2021. The past performance in the above table is based on the fund's objective and benchmarks (Target benchmark: GBP 3 Month LIBOR. No comparator benchmark) in place prior to this date. Going forward, this table will show past performance from this date based on the new objective and benchmarks (Target benchmark: ICE BofA Sterling 3 Month Government Bill Index. No comparator benchmark). Prior to 12.03.2014 the fund uses the track record of Cazenove Strategic Debt Fund (launched on 10.12.2007) as a performance track record.

Benchmarks: (If applicable)
