You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Fund has been created as a "Société d'Investissement à Capital Variable" governed by the Luxembourg law of 13 February 2007 relating to specialised investment funds, as amended.

The Fund qualified as an alternative investment fund in accordance with the provisions of the Luxembourg law of 12 July 2013 on alternative investment fund managers, as amended.

The Fund is an open-end fund.

Objectives

The Sub-Fund is a feeder fund of "Fimarge Fund - Fimarge Balanced Portfolio Fund" (the "Master Fund") and invests at

least 85% of its total net assets in the Master Fund. The Sub-Fund may invest its remaining assets (i.e. up to 15% of its total net assets) in cash or cash equivalent investments. The Master Fund is a Luxembourg mutual fund subject to the provisions of Part 1 of the Law of 2010. The Master Fund targets long-term capital growth through mixed, flexible, and non-indexed management using wide risk diversification.

Intended retail investor

This Sub-Fund may be suitable for investors looking for a higher risk income strategy to complement an existing core portfolio, or looking to potentially enhance medium term returns and who are comfortable with the extra risks inherent in the Sub-Fund. The Fund is exclusively targeted at well-informed investors who can be deemed to be advised investors.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The Sub-Fund is subject to credit risk, high yield securities, master feeder structure, equity risk, default risk, use of derivatives and liquidity risk.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If Andbank Asset Management Luxembourg is not able to pay you what is owed, you could lose your entire investment.
