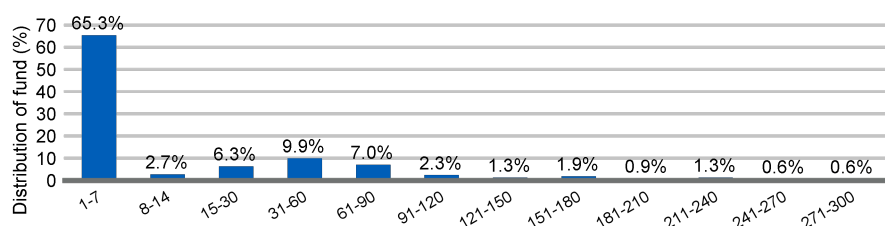
Investment Objective

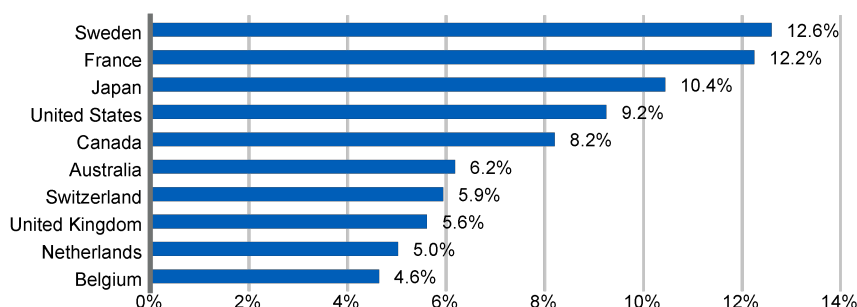

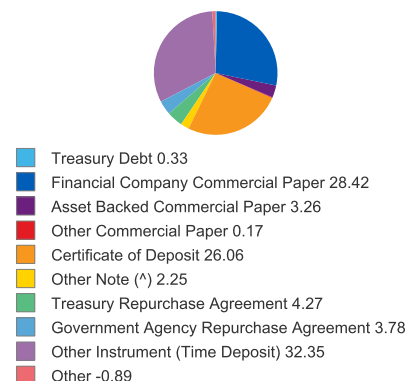

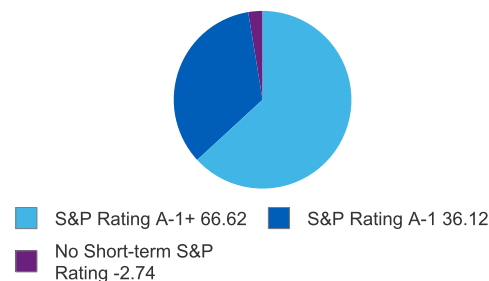

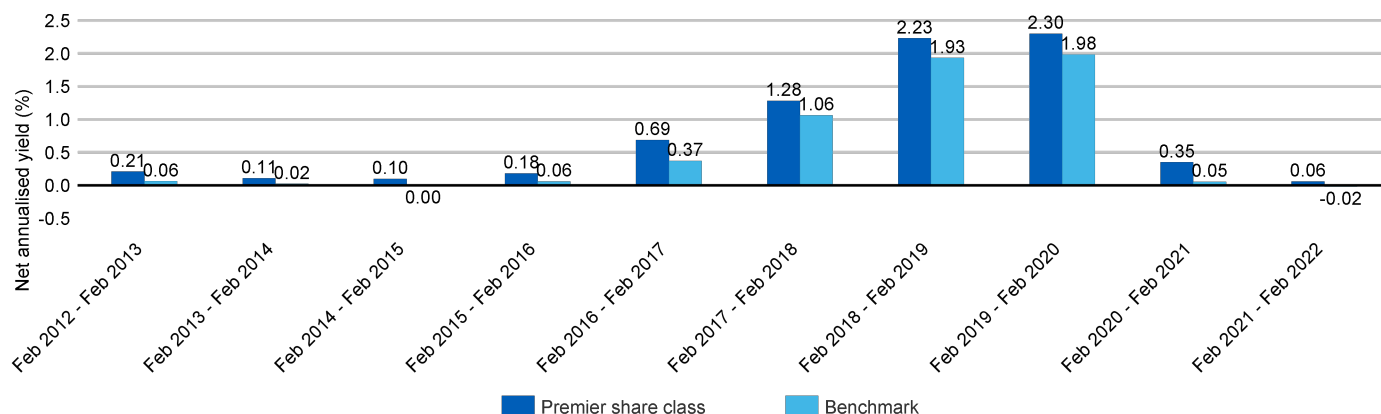

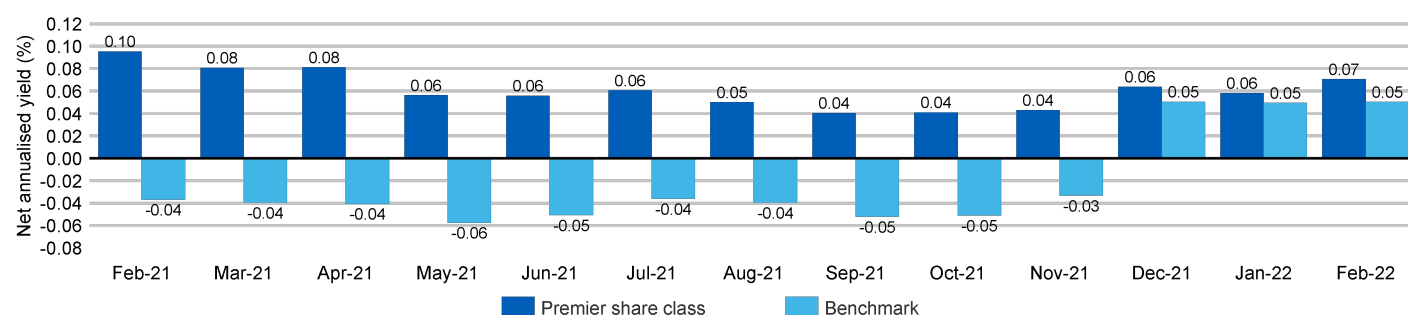

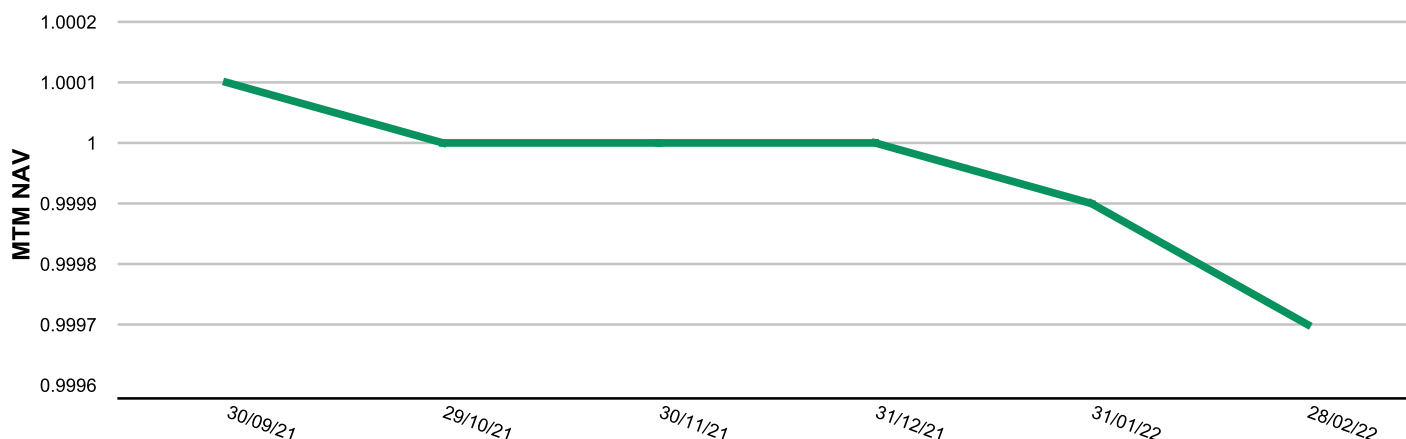
