Objectives and Investment Policy

Investment objective: The objective of the Sub-Fund is to outperform its benchmark by selecting investment grade securities issued by companies that meet environmental, social and governance (ESG) criteria.

Benchmark Index: The benchmark is Bloomberg Global Aggregate Corporate Index, hedged in EUR.

The benchmark index serves only for comparison purposes. The Sub-Fund is actively managed.

Investment policy: The Investment Manager will systematically include environmental, social and governance (ESG) factors in their financial analysis in order to select the highest-rated companies.

At least 90% of portfolio companies receive ESG rating. The selection process includes a positive screening by selecting through a best in universe approach and a negative screening, whereby the Investment Manager has established a formal exclusion policy that integrates the exclusion of controversial companies related to weapon, coal and tobacco. The Sub-Fund Classifies as Article 8(1) SFDR as it promotes a combination of ESG characteristics, although no reference benchmark has been designated for the purpose of attaining the environmental or social characteristics.

Environmental, social and governance (ESG) criteria are one of the components subject to management and are factored in the final investment decision, although their weighting is not defined beforehand.

In view of its ESG strategy, the Sub-Fund promotes environmental characteristics but does not invest in environmentally sustainable economic activities. The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities, in the context of the Taxonomy Regulation.

At least 80% of the Sub-Fund's total assets excluding cash will be invested in bonds without any sectorial or geographical constraints.

At least 85% of the Sub-Fund's total assets excluding cash will be invested in "investment grade" debt securities, i.e. those with a rating greater than or equal to BBB- or an equivalent category.

The debt securities may be denominated in USD, EUR or in any other currencies. However, the currency risk against the USD will not exceed 10% of the Sub-Fund's total assets.

The Sub-Fund may use financial derivative instruments to achieve its investment.

Under exceptional circumstances and/or where financial market conditions so require, the Sub-Fund may, with the aim of protecting shareholders' interests, invest all of its assets in term deposits, money market instruments or short term debt securities.

The Class will be hedged against the USD as the investment/exposure currency of the Sub-Fund.

The recommended minimum investment period is 2 years.

Frequency of share buying or selling: Every Luxembourg and France bank business day except for Good Friday, 24 December (Christmas Eve) and the days on which the French markets are closed (official calendar of Euronext Paris S.A.) for orders received by the transfer agent on each NAV calculation day before 12:30 p.m. and processed on the basis of that day's net asset value.

Significant risks not taken into account in this indicator:

Credit risk : When a significant level of investment is made in debt securities.

Liquidity risk : The markets for some securities and instruments may have limited liquidity. This limited liquidity could be a disadvantage to the Sub-Fund, both in the realisation of the prices quoted and the execution of orders at desired prices.

Impact of techniques such as derivative contracts : The use of derivatives instruments can infer a decrease of the asset more significant than the decrease of the invested underlying assets or markets.

Counterparty risk : Where a Fund is backed by collateral or has significant investment exposure through contracts with a third party.

Operational risk : The Sub-Fund may suffer losses due to the failure of operational processes, including those related to the safekeeping of assets.

The occurrence of any of these risks may negatively impact the net asset value.

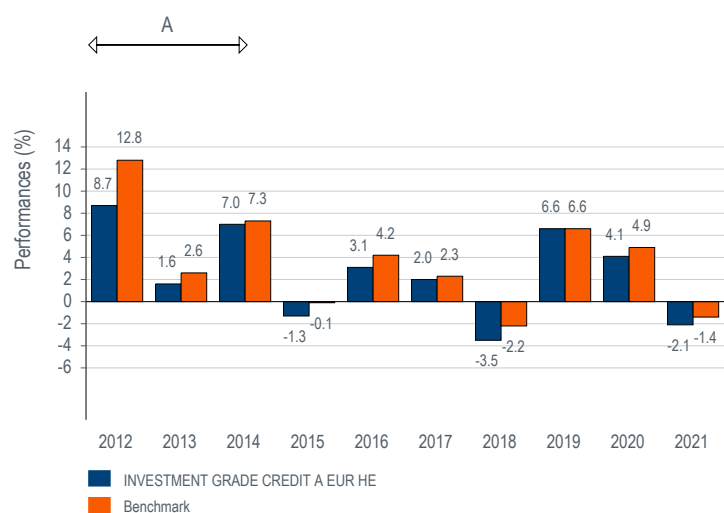
Charges and fees are paid to cover the operating costs of the Sub-Fund, including the cost of marketing and distributing share classes. These costs reduce the potential growth of your investment.
