Investment Objective

The fund invests in a broad range of asset classes with a particular focus on global equities and European bonds. The fund management pursues a sustainable and responsible investment strategy ("SRI strategy"), which takes environmental, social and governance criteria into account. The fund's objective is to attain a return over the medium term that is comparable to the return of a portfolio consisting of 50% global stocks and 50% European bonds. An integrated risk and volatility management will help to limit the volatility of the fund unit price to a pre-set range of 6 - 12% in the medium to long term.




Currency Breakdown (%) (incl. FX derivatives)




