Objectives and Investment Policy

The Fund seeks total return through a combination of current income and capital appreciation consistent with prudent risk management, while applying environmental, social and governance ("ESG") principles in the selection of securities. There is no assurance that such objective will be achieved.

The Fund refers to the J.P. Morgan Corporate EMBI Broad Diversified Index (the "Benchmark"). While the Fund is actively managed, the Benchmark will be used for risk management purposes and performance comparison purposes. The Benchmark is not a reference benchmark for the purpose of attaining the sustainability characteristics promoted by the Fund.

The Fund will primarily invest in a diversified portfolio comprising of investment grade and high yield corporate bonds and quasi-sovereign bonds in emerging market countries, denominated in US Dollars, Euro, Yen, Sterling or in emerging market currencies and which will generally be listed or traded on a regulated market. The Fund may also invest in, without limitation emerging market debt securities (including loan participation notes) issued by corporate, quasi-sovereign, sovereign and supranational issuers, corporate and sovereign debt from developed nations, private placements, short term investments, commercial paper, financing arrangements and cash equivalents, non-rated or defaulted securities and regulated money market or short term investments.

The debt securities (contracts to repay borrowed money that typically pay interest) in which the Fund invests can be investment grade, below-investment grade and non-rated

The Fund may also use (to a significant extent), for investment, risk management or hedging purposes, exchange-traded and over-the-counter derivatives (including, futures and options, currency forwards, credit default swaps, credit default swap indices, total return swaps, currency swaps, interest rate swaps, inflation swaps, and swaptions), the underlying reference assets for which will be bonds, in which the Fund may invest directly (as set out herein), interest rates, currencies and indices. The Fund may also engage in efficient portfolio management techniques.

The Fund may not be leveraged in excess of 100% of its net asset value, through the use of derivatives

The Investment Manager has determined that the Fund promotes sustainability characteristics due to its use of its internal evaluation process, and is therefore classified under Article 8 of the Sustainable Finance Disclosures Regulation ("SFDR"). The evaluation process analyses securities based on ESG criteria established by PGIM Fixed Income's ESG committee (the "ESG Committee"). The Fund seeks to avoid investing in issuers that engage in activities that are not in compliance with certain socially-responsible investment criteria set forth by the ESG Committee. Although the Fund promotes sustainability characteristics, the Fund does not have sustainable investment as its investment objective.

It is not currently anticipated that dividends will be declared in respect of the Class. Net investment income attributable to the Class is expected to be retained by the Fund, which will increase the net asset value per share of the Class.

Portfolio transaction costs, which are paid by the Fund in addition to the costs set out under "Charges" below, may have a material impact on the performance of the Fund.

Investors can buy and sell their shares on each business day of the Fund.

The Fund may not be appropriate for investors who plan to sell their shares within the short term

The shares are denominated in US Dollars. The base currency of the Fund is the US Dollar.




Charges
