Objectives and investment policy

The Fund seeks to grow your capital and generate income by investing primarily in regulated UCITS and non-UCITS funds which have as investment objective to invest in alternative strategies such as but not limited to Equity Long Short, Equity Market Neutral, Fixed Income Arbitrage, Global Macro, Commodity Trading Advisor (trend followers).

Commodity Trading Advisor (trend followers).

The non-UCITS funds will have an investment policy and a risk exposure similar to the UCITS funds and will be submitted to a regulatory supervision equivalent to a UCITS.

The Fund is actively managed and will provide a diversified source of return by undertaking a careful manager selection in order to decrease the risk described in normal market conditions.

The Fund will also invest in eligible closed ended UCIs which are listed or dealt on a regulated market.

The Fund is not managed in reference to a benchmark.

The Fund can invest in Contingent Convertible bonds ("CoCos"), through funds which invest on an ancillary basis in CoCos.

On an ancillary basis, the Fund may also invest in liquid assets up to 20% of its net assets, as well as derivative instruments for hedging and/or investment and/or efficient portfolio management purposes.

The Fund's base currency is USD.

As a fund of funds implementing alternative strategies, investors should be aware that the value of their holdings could fall and that they may not get back their initial investment.

The share currency risk in relation to the Fund's base currency is mainly hedged.

Any income received by the Fund is reinvested (capitalisation share class).

Investors in the Fund can redeem their units on a weekly basis, each Friday.


