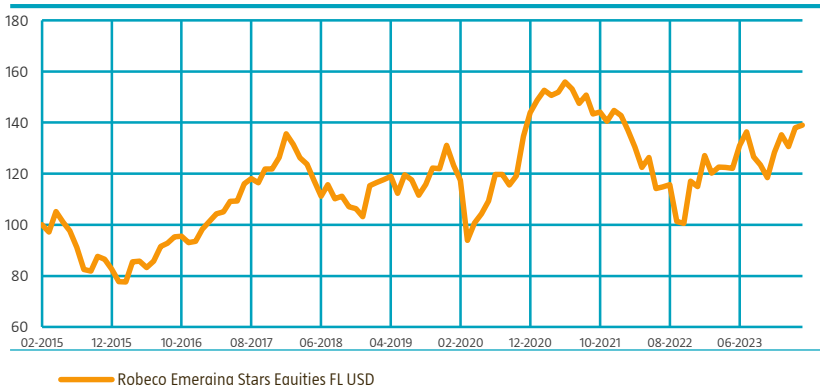

### Performance

Based on transaction prices, the fund's return was 0.77%.

In March, the fund underperformed the MSCI Emerging Markets Index. The underperformance was driven by stock selection, while country allocation was positive. Positive country allocation was driven by South Korea (overweight), India and Saudi Arabia (both overweight). Negative country allocation came from Taiwan (underweight), Greece and Hungary (both overweight). Stocks that underperformed in March were to be found in China, were Alibaba (e-commerce), Vipshop (online retailer), Ping An (life insurance) and PICC P&C (general insurance) lagged. In Brazil, the oil company Petrobras and the Hungarian bank OTP also underperformed in March. Other noteworthy underperformers were KIA Motors (South Korean car manufacturer) and Micro-Star (Taiwanese high-performance gaming computers). Stocks that did perform relatively well in March included: iQIYI (Chinese online video platform), Xinyi Solar (Chinese solar panel manufacturer), Samsung Electronics (South Korean memory chips and electronics), Naspers (South African based EM internet holding company), CTBC (Taiwanese insurer) and Taiwan Semiconductor Manufacturing Company (Taiwanese foundry).

### Market development

In March, emerging markets were up 2.68% (MSCI EM, in EUR), and thus slightly underperforming versus MSCI World (+3.42%). The largest positive contributors to the absolute performance were South Korea, Taiwan and Mexico. Despite a surprise policy rate hike from its central bank, Taiwan continued to outperform on the further pick-up in AI. The share price of TSMC refreshed all-time highs, as it is emerging as the enabler for almost all AI processing. South Korea also continues to rally on the back of the 'value-up' and AI themes. Mexico performed nicely on the back of the start of the monetary easing cycle. Emerging Asia outperformed the other regions. EMEA was the weakest region, where Egypt was down 33% after it devalued its currency. With regard to sectors, information technology, materials and communication services were the strongest performing ones. Crude oil prices increased by 4.5% on a tighter supply outlook while natural gas prices continued to fall on sluggish demand. The precious and industrial metal indices were also up significantly. In March, EM equity funds witnessed outflows of USD 2 billion globally, bringing the cumulative inflow to USD 1.5 billion year-to-date.

### Expectation of fund manager

The environment is still challenging for global equity markets, as interest rates have risen significantly in 2023. On the positive side, inflation has come down, and we may have seen the peak in the main bond yields. Emerging markets seem relatively well positioned, with lower inflation in many countries and there is more room for interest rate cuts due to a more aggressive hiking cycle in the past years. Brazil and some other Latin American countries have already started to cut rates. Growth in emerging markets is holding up relatively well. In China, although the property sector remains weak, the economy is still growing by around 5%. Emerging equity markets are attractively valued relative to developed markets, with discounts of around 30% based on earnings multiples. Earnings growth this year has disappointed, but should recover next year, with 18% growth expected. 2024 will be an important political year with elections in countries like Taiwan, India, South Africa, Mexico and Indonesia. By and large, we do not expect a major change in policy direction in these countries.

### Top 10 largest positions

TSMC and Samsung Electronics are two globally leading technology companies that combine good growth prospects with attractive valuations. The valuation for Chinese e-commerce company Alibaba has become much more attractive, while it still has positive growth opportunities. Naspers is a South Africa-listed holding company for Tencent and several other internet companies across emerging markets, and is trading at a large discount to the underlying value. Several banks from various emerging countries also appear in the top ten. Here we see attractive valuations and structural growth opportunities.

Sustainability

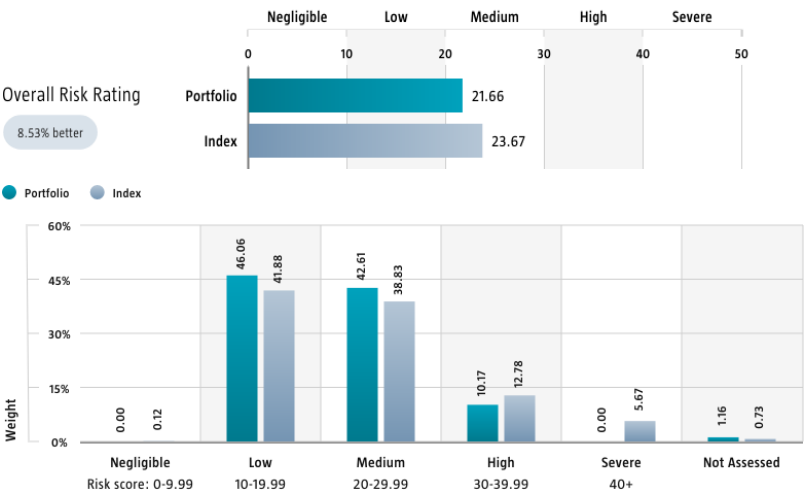
The fund incorporates sustainability in the investment process through exclusions, ESG integration, engagement and voting. The fund does not invest in issuers that are in breach of international norms or where activities have been deemed detrimental to society following Robeco's exclusion policy. Financially material ESG factors are integrated in the bottom-up investment analysis to assess existing and potential ESG risks and opportunities. In the stock selection the fund limits exposure to elevated sustainability risks. In addition, where a stock issuer is flagged for breaching international standards in the ongoing monitoring, the issuer will become subject to engagement. Lastly, the fund makes use of shareholder rights and applies proxy voting in accordance with Robeco's proxy voting policy.

The following sections display the ESG-metrics for this fund along with short descriptions. For more information please visit the sustainability-related disclosures. The index used for all sustainability visuals is based on MSCI Emerging Markets Index (Net Return, USD).

Sustainalytics ESG Risk Rating

The Portfolio Sustainalytics ESG Risk Rating chart displays the portfolio's ESG Risk Rating. This is calculated by multiplying each portfolio component's Sustainalytics ESG Risk Rating by its respective portfolio weight. The Distribution across Sustainalytics ESG Risk levels chart shows the portfolio allocations broken into Sustainalytics' five ESG risk levels: negligible (0-10), low (10-20), medium (20-30), high (30-40) and severe (40+), providing an overview of portfolio exposure to the different ESG risk levels. Index scores are provided alongside the portfolio scores, highlighting the portfolio's ESG risk level compared to the index.

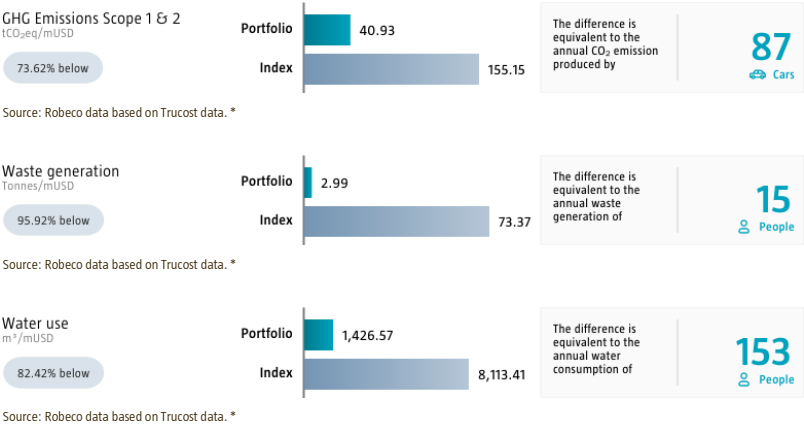

Environmental Footprint

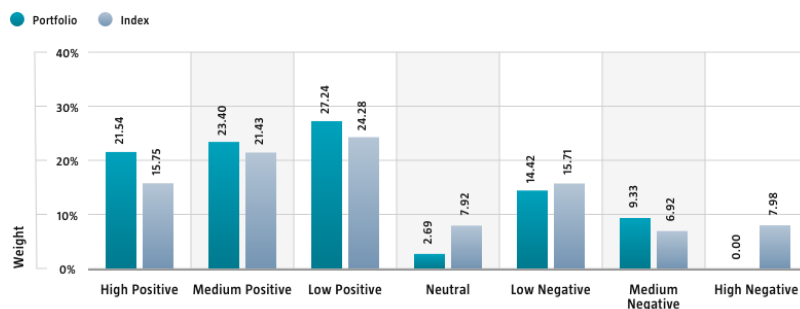
Environmental footprint expresses the total resource consumption of the portfolio per mUSD invested. Each assessed company's footprint is calculated by normalizing resources consumed by the company's enterprise value including cash (EVIC). We aggregate these figures to portfolio level using a weighted average, multiplying each assessed portfolio constituent's footprint by its respective position weight. For comparison, index footprints are shown besides that of the portfolio. The equivalent factors that are used for comparison between the portfolio and index represent European averages and are based on third-party sources combined with own estimates. As such, the figures presented are intended for illustrative purposes and are purely an indication. Only holdings mapped as corporates are included in the figures.

## SDG Impact Alignment

This distribution across SDG scores shows the portfolio weight allocated to companies with a positive, negative and neutral impact alignment with the Sustainable Development Goals (SDG) based on Robeco's SDG Framework. The framework utilizes a three-step approach to assess a company's impact alignment with the relevant SDGs and assign a total SDG score. The score ranges from positive to negative impact alignment with levels from high, medium or low impact alignment. This results in a 7-step scale from -3 to +3. For comparison, index figures are provided alongside that of the portfolio. Only holdings mapped as corporates are included in the figures.

## Engagement

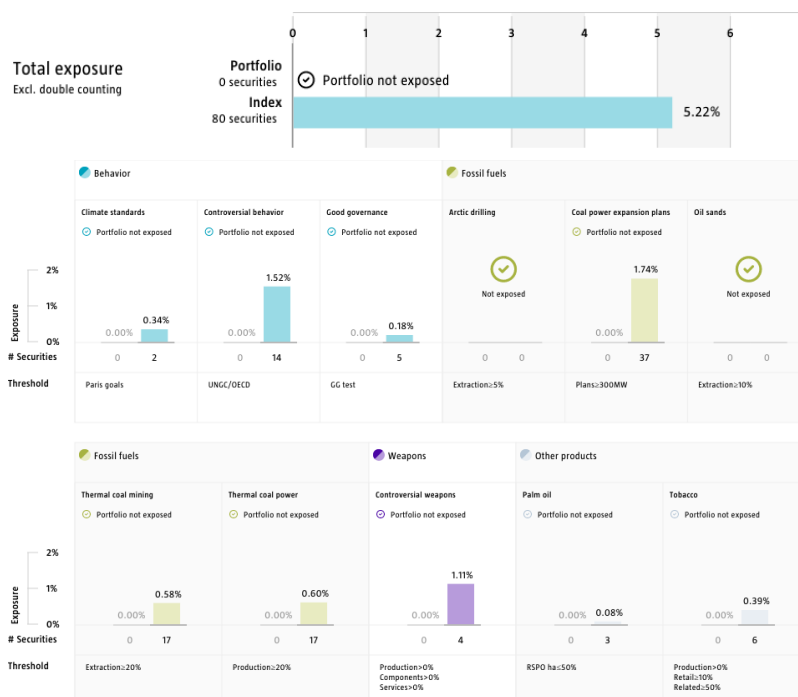
Robeco distinguishes between three types of engagement. Value Engagement focuses on long-term issues that are financially material and/or are causing adverse sustainability impacts. The themes can be broken into Environmental, Social, Governance, or Voting-related. SDG Engagement aims to drive a clear and measurable improvement in a company's SDG contribution. Enhanced engagement is triggered by misconduct and focuses on companies severely breaching international standards. The report is based on all companies in the portfolio for which engagement activities have taken place during the past 12 months. Note that companies may be under engagement in multiple categories simultaneously. While the total portfolio exposure excludes double counting, it may not equal the sum of individual category exposures.

The fund's objective is to achieve a better return than the index. The fund selects investments based on a combination of top-down country analysis and bottom-up stock selection. We focus on companies that have both a healthy and solid business model growth prospects as a reasonable valuation. The fund has a focused, concentrated portfolio with a small number of larger bets.

The fund promotes E&S (i.e. Environmental and Social) characteristics within the meaning of Article 8 of the European Sustainable Finance Disclosure Regulation, integrates sustainability risks in the investment process and applies Robeco's Good Governance policy. The fund applies sustainability indicators, including but not limited to, normative, activity-based and region-based exclusions, and proxy voting.

The majority of stocks selected will be components of the Benchmark, but stocks outside the Benchmark may be selected too. The fund can deviate substantially from the weightings of the Benchmark. The fund aims to outperform the Benchmark over the long run, whilst still controlling relative risk through the applications of limits (on VaR Ratio) to the extent of deviation from the Benchmark. This will consequently limit the deviation of the performance relative to the Benchmark. The Benchmark is a broad market weighted index that is not consistent with the ESG characteristics promoted by the fund.

### Fund manager's CV

Jaap van der Hart is the Lead Portfolio Manager of Robeco's High Conviction Emerging Stars strategy. Over time, he has been responsible for the investments in South America, Eastern Europe, South Africa, Mexico, China and Taiwan. He also coordinates the country allocation process. He started his career in the investment industry in 1994 at Robeco's Quantitative Research department and moved to the Emerging Markets Equity team in 2000. Jaap holds a Master's in Econometrics from Erasmus University Rotterdam. He has published several academic articles on stock selection in emerging markets. Karnail Sangha is a Portfolio Manager within the Emerging Markets Equity team and provides analytical research coverage on India. He is Co-Portfolio Manager for the Emerging Stars and Sustainable Emerging Stars Equity strategies. Prior to joining Robeco in 2000, Karnail was a Risk Manager/Controller at Aegon Asset Management where he started his career in the industry in 1999. He holds a Master's in Economics from Erasmus University Rotterdam and is a CFA® charterholder. Karnail is also fluent in Hindi and Punjabi.
