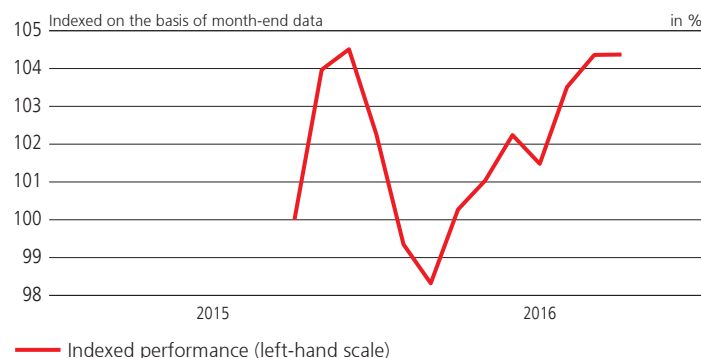
## *UBS Strategy Balanced (CHF)*
