INVESTMENT POLICY

The compartment's objective is to build a portfolio offering the best possible ratio between estimated risk and absolute return by implementing a systematic strategy that monitors the trends of a diverse range of asset classes worldwide.

The fund is invested according to an approach that involves taking long positions in assets with a positive trend, and short positions in assets with a negative trend, so as to profit in both bull and bear markets. Portfolio construction is risk based, with riskier instruments receiving lower capital allocation than less risky ones.




1: Uni-Global - Cross Asset Trend Follower ZA-USD I 2: SG Trend Index






CAPITAL ALLOCATION BY ASSET CLASS
