FUND OVERVIEW

The Fund follows a flexible asset allocation policy by investing across the full capital structure of companies and the full spectrum of securities issued by governments and their agencies. In order to achieve its investment objective and policy, the Fund will invest in the full spectrum of permitted investments including fixed income transferable securities, equity-related securities, units of undertakings for collective investment, cash, deposits and money market instruments.


