


## **Investment Policy**

The fund is managed with an indexed method and is distinguished by broad diversification, low tracking errors, and low-cost management. The investment objective is to replicate the reference index as closely as possible and to minimize performance deviations from the benchmark. The MSCI EMU (NR) Index captures large and mid cap representation across the Developed Markets countries in the EMU (European Economic and Monetary Union). The index covers approximately 85% of the free float-adjusted market capitalization in the EMU equity universe.


