(ISIN:LU1039623316) Man AHL Alpha Core Alternative (the 'Fund') is a sub-fund of Man Umbrella SICAV (the 'Company'). Waystone Management Company (Lux) SA (formerly named MDO Management Company), is the Manager of the Company.

Objectives and investment policy

- The Fund seeks to achieve medium-term capital growth while restricting the associated risks, by trading a diversified portfolio of Investments.
- The Fund aims to perform independently of traditional stock and bond investments thereby providing valuable diversification benefits and enhancing the risk/reward profile of a traditional investment portfolio.
- In order to achieve its investment objective the Fund employs a systematic, statistically based investment approach that is predominantly designed to identify and capitalise on upward and downward price trends across global markets. Investment decisions are entirely driven by mathematical models based on market trends and other historical relationships.
- The Fund invests in a varied portfolio of financial derivative instruments (i.

 e. instruments whose prices are dependent on one or more underlying assets ('FDI')) including, without limitation, futures and forward contracts.
 The Fund may access these global markets directly or indirectly and include, without limitation, stocks, bonds, currencies and short-term interest rates.


Charges
