

They offer sustainable and above-average growth with high profitability and are often owner-managed. Decisive criteria are end markets with structural growth, high entry barriers and excellent management teams.

Fund management comment

The reporting season continued in February with mixed results. The consumer sector showed no signs of recovery, and the continued high level of interest rates is unlikely to leave the markets unscathed. Berenberg Aktien Mittelstand performed negatively compared to the benchmark. On the negative side, the shares of Encavis and Energiekontor came under pressure due to the current weakness in the sector and the sharp fall in electricity prices. Compugroup also performed disappointingly after the company reported significant one-off costs in the fourth quarter in connection with a restructuring program. On the positive side, adesso reported encouraging figures for the fourth quarter and a solid outlook for the coming year. Reports that Novartis is in advanced talks to acquire Morphosys boosted Morphosys shares. Improved margins, strong operating growth, and good progress in reducing inventories in the first quarter led to a pleasing share price reaction at Carl Zeiss. In February, we opened an initial position in SAF Holland, a manufacturer of chassis-related assemblies and components for trailers, trucks, and buses.






Consideration of ESG Elements

Identifying companies and business models that will be successful in the long term is the basis for good investment decisions. Environmental, Social and Governance (ESG) factors are key factors in decision making and are therefore integral components of the investment process.

CO₂ Intensity


The fund does not actively manage its carbon footprint, however, emissions data such as CO2 intensity are relevant parameters which can be used to assess the efficient management of a company and the extent of transition risks.

Weighted average CO₂ intensity - in tons of CO₂ per USD 1 million revenues




ESG Score

The data provider MSCI ESG uses an ESG score of 0 to 10 to assess the management of material ESG risks of portfolio holdings compared to competitors.



ESG Controversies Screen

Investments in the fund are monitored for ESG controversies and, with the help of MSCI ESG data, flagged according their severity. Thereby, potential ESG risks of investments are identified. In the case of an orange flag (severe controversy), we enter into an active exchange with the company. In the case of a red flag (very severe controversy), the company is excluded.

Glossary & Methodology

Active Ownership

The term "Active Ownership" encompasses all our activities where we, as an investor, attempt to positively influence a company's management of ESG aspects. This includes Engagement, i.e. direct dialogue with companies to discuss specific ESG objectives as well as proxy voting, i.e. our voting recomendations to our fund administrator, which then exercises the voting rights at general meetings.

CO₂ Intensity

The CO2 Intensity (Scope 1 & 2 emissions) per company is multiplied by is portfolio weight (current value of the investment by current portfolio value) and summed up. This weighted average CO2 Intensity provides an indication of the portfolio's exposure to CO2-emission intensive companies.

ESG Score

Using a score between 0 (lowest) and 10 (highest), MSCI ESG assesses the ability of portfolio holdings to identify and manage environmental, social and governance-related risks compared to peers. The ESG scores are assigned at the holding level and are aggregated at the portfolio level as the weighted average ESG Score.

ESG Controversies Screen

MSCI ESG analyses controversial business practices from the five areas environment, human rights, labour rights & supply management, customers and governance. The controversies are rated according to their reputational risk as well as the operational handling by a flagging system. Green indicates no or weak controversies, yellow indicates moderate controversies, orange indicates severe controversies and red indicates very severe controversies.
