
INVESTMENT OBJECTIVE

The Fund seeks to deliver current income and the opportunity for capital appreciation by investing primarily in U.S. investment grade corporate, government, and mortgage- and asset-backed securities, with select allocations to high yield and non-U.S. securities.

PORTFOLIO POSITIONING (AS OF 30/09/2016)


- Although we broadly maintained the portfolio's up-in-quality bias, we emphasized risk sectors early in the quarter, as spreads widened following the United Kingdom's vote to leave the European Union. In the second half of the quarter, we modestly lowered the portfolio's aggregate risk exposure as spreads tightened, valuations became realized, and the potential for event-risk to cause near-term volatility increased.
- As risk assets rallied in July and August, we reduced the portfolio's allocation to credit-sensitive sectors, particularly high yield and investment grade corporates, realizing profits. High yield corporates benefited from a continued search for yield and stabilizing energy prices. Within investment grade corporates, we tactically reduced the portfolio's overweight to 'BBB' rated corporate debt; however, we still view this portion of the corporate sector positively, as these companies are less likely to increase leverage to fund mergers and acquisitions or share buybacks.
- Given our expectation for increased volatility, we lowered the portfolio's exposure to agency mortgagebacked securities (MBS). Within the portfolio's agency MBS allocation, the portfolio is allocated to favored coupons of Fannies AMA- and Freddie Mac-backed securities.
- Broadly speaking, we believe that the U.S. economy will continue to grow at a steady, albeit subpar, pace. This view, coupled with valuations, means that we are constructive on domestically focused asset classes. The portfolio's exposure to asset-backed securities (ABS) generated strong risk-adjusted returns, while providing additional liquidity to the portfolio. During the quarter, we expanded the portfolio's overweight within the sector, owing to the attractiveness of spreads in lower-rated, investment-grade tranches. Later in the quarter, we tactically rotated into higher-quality issues, due to their more liquid nature. The ABS sector continues to present unique opportunities to find pockets of relative value and attractive risk-adjusted spread.

GLOSSARY OF TERMS

Effective Duration is the change in the value of a fixed income security that will result from a 1% change in interest rates, taking into account anticipated cash flow fluctuations from mortgage prepayments, puts, adjustable coupons, and potential call dates. Duration is expressed as a number of years, and generally, the larger a duration, the greater the interest-rate risk or reward for a portfolio's underlying bond prices. Where applicable, certain investments, such as common or preferred stock, convertible bonds and convertible preferred stock, ETFs, ADRs, and CPI swaps and related futures, are excluded from these calculations. Average Life measures how long it will take, on average, to receive the repayment of the principal amount on a debt security. Average life is often used in connection with mortgagebacked securities as a measurement of the length of time, on average, before the underlying mortgages are paid, refinanced, or otherwise retired. Average Coupon is the weighted average coupon for all the securities in a portfolio. A bond's coupon is the annual rate of interest on a bond's face value that the issuer agrees to pay the holder. 

The performance of the Composite is shown net and gross of advisory fees, and reflects the deduction of transaction costs. The deduction of advisory fees and expenses (and the compounding effect thereof over time) will reduce the performance results and, correspondingly, the return to an investor. The table above also includes net performance for the Composite and reflects the deduction of the actual advisory fee borne by each account in the Composite and other trading expenses and performance incentive fees. Portfolio incentive fees are applied on a cash basis in the period in which they are paid. The effect of fees and expenses on performance will vary with the relative size of the fee and account performance. For example, if \$10 million were invested and experienced a 10% compounded annual return for 10 years, its ending dollar value, without giving effect to the deduction of the advisory fee, would be \$25,937,425. If an advisory fee of 0.30% of average net assets per year for the 10-year period were deducted, the annual total return would be 9.67% and the ending dollar value would be \$25,238,659. The management fee schedule is as follows: 0.30% on the first \$50 million, 0.23% on the next \$100 million, 0.20% on the next \$100 million and 0.19% on all assets over \$250 million.
