The Fund has appointed FundPartner Solutions (Europe) S.A. as management company.

Objectives and investment policy

The objective of the Sub-Fund is to achieve over the long term a total return as high as possible by investing worldwide, including Russia and the People's Republic of China (PRC), mainly in debt securities of borrowers whose credit rating assigned by Standard & Poor's Corporation is not lower than B or its equivalent by Moody's or another rating agency.

The Sub-Fund is actively managed. The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

Investments made in the PRC will be made exclusively in in debt or equities securities traded in, or exposed to, the offshore Renminbi (the CNH, accessible outside the PRC and traded primarily in Hong Kong), the HKD, the EUR, the USD, the JPY, the GBP or the AUD. The Sub-Fund may at any time be totally invested in one single currency, at the context of except of the AUD.

or in one single category of assets.

The Sub-Fund may invest in all types of debt securities such as fixed-rate or floating-rate bonds and notes, zero coupon bonds and notes, multiple currency bonds, any other type of debt securities. However, the Sub-Fund will not invest in asset-backed securities and mortgage-backed securities.

Direct investments (local shares) in Russia (which are not traded on the Moscow Interbank Currency Exchange - Russian Trading System Stock Exchange) will in aggregate not exceed 10% of the Sub-Fund's net assets.

The Sub-Fund is authorised to invest on an ancillary basis in other eligible financial instruments, such as equities, cash. The Sub-Fund can also invest in financial derivative instruments, for currency hedging and/or for other purposes.

Dealing Frequency

The net asset value for the Class is calculated on each business day ("the Valuation Day").

The cut-off time to submit subscription orders is 4 p.m., one business day

before the relevant Valuation Day.

The cut-off time to submit redemption orders is 4 p.m., one business day before the relevant Valuation Day.

Distribution Policy

The Class is cumulative. No dividend will normally be distributed.

Currency

The currency of the Class is USD.

This is a currency hedged class. It aims to reduce the impact on your investment of movements in the exchange rate between the Sub-Fund currency and the Class currency.

Investment Horizon

The Class may be suitable for investors with at least a three-year investment horizon.

Minimum investment and/or holding requirement

The minimum subscription and holding amount is USD 1'000 or equivalent.

Why is this Sub-Fund in this category?

The objective of the Sub-Fund is to achieve over the long term a total return as high as possible by investing worldwide (including Russia and the PRC) on regulated markets. Therefore, the Sub-Fund will present a risk/reward profile corresponding to the medium level of the SRRI scale.

Are there any other particular Risks?

Risks that could affect fund performance and are not necessarily fully reflected in the risk and reward rating include:

- Liquidity risks: The Sub-Fund may invest part of its assets in less liquid securities. Those are securities that cannot easily be sold or exchanged for cash without a substantial loss in value in certain market conditions. Those securities also cannot be sold quickly because of a lack of ready and willing investors or speculators to purchase the asset.
- Counterparty risks: The Sub-Fund can conclude various transactions

with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Sub-Fund.

- · Credit risks: The Sub-Fund may invest a portion of its assets in debt securities. The issuers of these debt securities may become insolvent, which will mean that the securities will lose all or some of their value.
- Risks from the use of derivatives: The Sub-Fund may use financial derivatives instruments which may result in the sub-fund being leveraged and may result in material fluctuations in the value of the Sub-Fund. Leverage on certain types of transactions including derivatives may impair the Sub-Fund's liquidity, cause it to liquidate positions at unfavourable times or otherwise cause the sub-fund not to achieve its intended objective.

Leverage occurs when the economic exposure created by the use of derivatives is greater than the amount invested resulting in the sub-fund being exposed to a greater loss than the initial investment.

 Operational risks: The Sub-Fund may fall victim to fraud or criminal acts. It may suffer losses as a result of misunderstandings or mistakes by employees of the management company or by external third parties or may be damaged by external events, such as natural disasters.

Performance fee

Paid annually to the investment manager and equivalent to 5.00% of the performance of the net asset value per share exceeding the high water mark as defined in the prospectus.

The charges you pay are used to pay the cost of running the Sub-Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

These percentages are maximum figures which might be charged by intermediaries, in some cases you might pay less. The actual entry and exit charges can be found out from your adviser or distributor.

The percentage of ongoing charges is based on the last year's expenses, ending 31/12/2020. This figure may vary from year to year. It excludes:

- Portfolio transaction costs, except in the case of an entry/exit charge paid by the Sub-Fund when buying or selling units in another collective investment undertaking.


For the last financial year, the performance fee charged to the Class was 0.00% of the average annual net assets of the Class.
