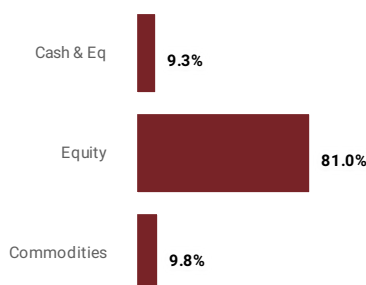

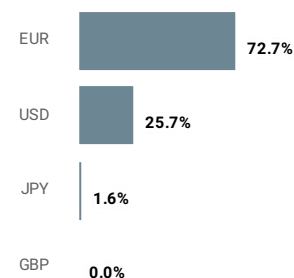

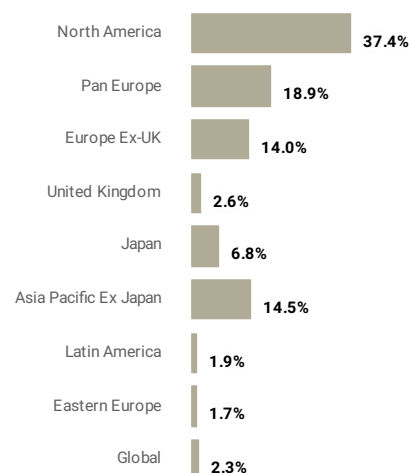

## CURRENCY BREAKDOWN

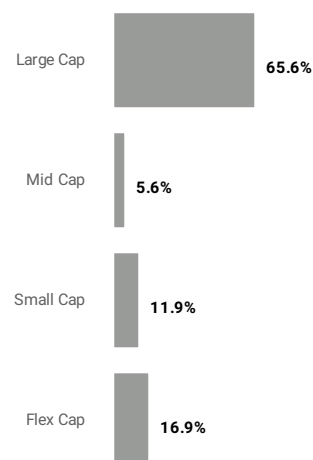


## EQUITY ALLOCATION\*
