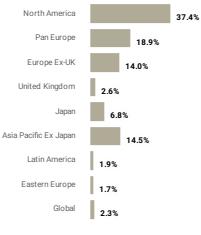

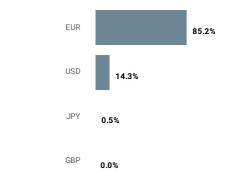


## **QUITY ALLOCATION\***

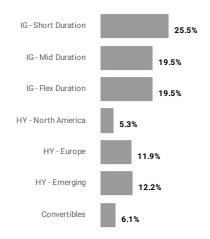
