The manager aims to invest in companies with track records of generating consistent returns, which demonstrate above average free cash flow predictability, and where we believe a company's long term opportunities are not necessarily reflected in today's share price. The investment process includes a strong focus on risks arising from the transition to a more sustainable global economy, as well as seeking to harness the opportunities.

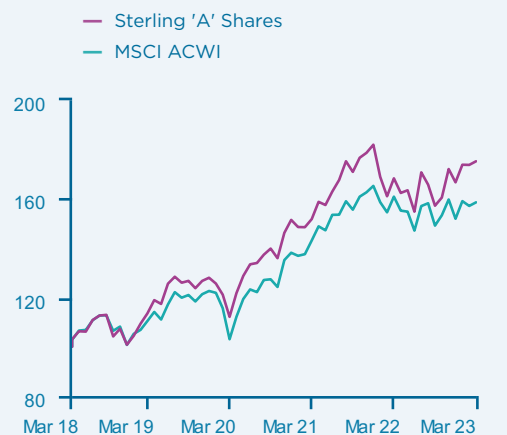
