# Objectives and Investment Policy

#### **Objectives**

The fund aims to provide capital growth over a 3-5 year investment cycle by investing in commodity related instruments worldwide.

#### **Investment Policy**

The fund will invest in the energy, agriculture and metals sectors worldwide. Investments can be made indirectly through derivatives and exchange traded funds and/or directly in equities and commodity related transferable securities. The fund will not acquire any physical commodities directly.

The fund may use derivatives to increase investment gains and to reduce its exposure to various investment risks (hedging).

The fund may use leverage up to 50% of its net assets and take short positions.

The fund may also hold substantial levels of cash (exceptionally this may represent 100% of the fund's net assets).

#### **Benchmark**

This share class is not managed with reference to a financial index.


#### **Dealing Frequency**

You may redeem your investment upon demand. This fund deals daily.

#### **Distribution Policy**

This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.

### The risk and reward indicator

#### **Risk factors**

The following risks may affect fund performance.

Counterparty risk: The counterparty to a derivative or other contractual agreement or synthetic financial product could become unable to honour its commitments to the fund, potentially creating a partial or total loss for the fund.

Counterparty risk / money market & deposit: A failure of a deposit institution or an issuer of a money market instrument could create losses.

Currency risk: The fund can be exposed to different currencies. Changes in foreign exchange rates could create losses.

Derivatives risk: A derivative may not perform as expected, and may create losses greater than the cost of the derivative.

Emerging markets & frontier risk: Emerging markets, and especially frontier markets, generally carry greater political, legal, counterparty and operational risk.

Equity risk: Equity prices fluctuate daily, based on many factors including general, economic, industry or company news.

Interest rate risk: A rise in interest rates generally causes bond prices to fall.

Leverage risk: The fund uses derivatives for leverage, which makes it more sensitive to certain market or interest rate movements and may cause above-average volatility and risk of loss.

Liquidity risk: In difficult market conditions, the fund may not be able to sell a security for full value or at all. This could affect performance and could cause the fund to defer or suspend redemptions of its shares.

Operational risk: Failures at service providers could lead to disruptions of fund operations or losses.

Short selling risk: The fund may take positions that seek to profit if the price of a security falls. A large rise in the price of the security may cause large losses.
