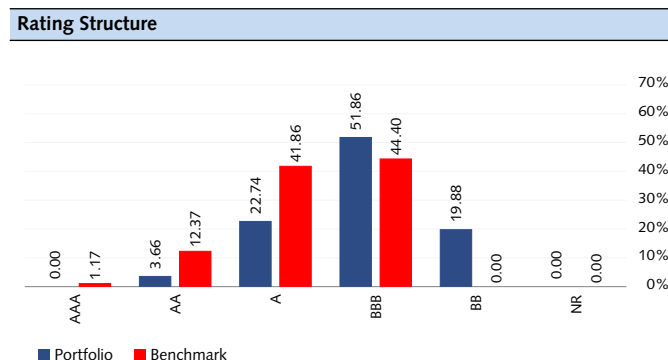


Vontobel Fund - Global Corporate Bond Mid Yield H (hedged) EUR

The fund is an actively managed corporate bond fund. It aims to exceed average Investment Grade returns by focusing on the Lower Investment Grade segment of the global corporate universe. Investment decisions are based on top down and bottom up fundamental analysis, by evaluating economies, industry environments, issuers and their capital structures.

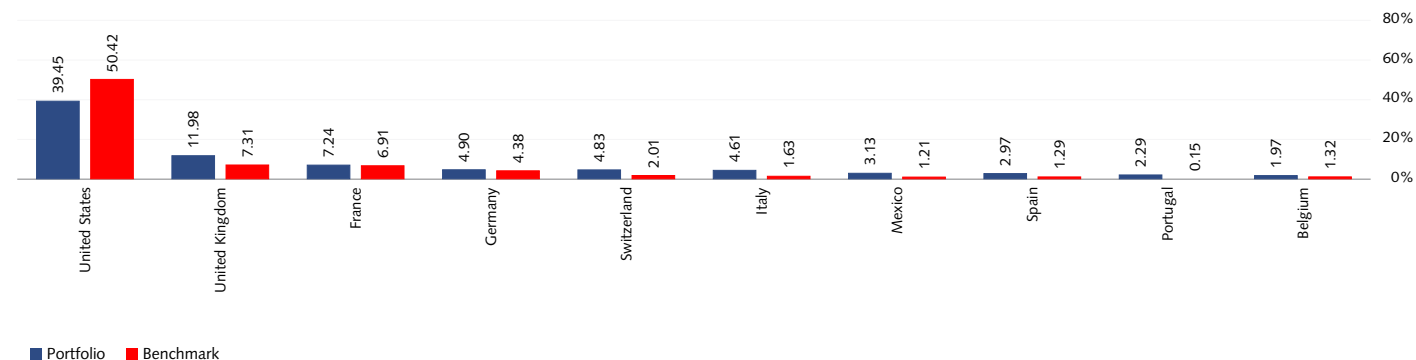
- Min. 67% of the fund invested in corporate bonds rated between A+ and BBB-
