Objectives and Investment Policy

Objective To seek current income.

Portfolio securities Under normal circumstances, the Sub-Fund invests mainly in a broad range of government and corporate bonds from anywhere in the world, including emerging markets. It may also invest up to 100% of its assets in asset-backed securities (ABS) and mortgage-backed securities (MBS). The Sub-Fund aims, without guarantee, to maintain an effective duration (a measure of interest rate sensitivity) ranging from 0 to 3 years.

The Sub-Fund may use derivatives for hedging (reducing risk) and to seek investment gains.

The Sub-Fund is actively managed. The Sub-Fund is not managed in reference to a benchmark.

Investment process In choosing investments, the investment manager uses a controlled risk approach by combining macroeconomic, interest rate and sector performance data analysis with an assessment of individual securities.

Designed for This sub-fund may not be appropriate for investors who plan to withdraw their money within three years.

ABS/MBS Bonds that are backed by consumer debt (such as mortgages or credit card debt) and whose income derives from the payments received from borrowers.

Bonds Securities that represent an obligation to repay a debt, along with interest.

Derivatives Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

Emerging markets Markets of less economically developed nations, such as some nations in Asia, Africa, Eastern Europe and Latin America.

You can usually buy or sell fund shares every day that is a banking day in Luxembourg and The New York Stock Exchange (NYSE).

These shares are accumulation shares (meaning any income received is retained in the value of the shares).

Default risk The issuers of certain bonds could become unable to make payments of interest and principal when due. Such risk is higher if the Sub-Fund invests in distressed securities or holds defaulted securities.

Derivatives risk Certain derivatives could increase Sub-Fund volatility or expose the Sub-Fund to losses greater than the cost of the derivative.

Liquidity risk Certain securities could become hard to value, or to sell at a desired time and price.

Management risk Portfolio management techniques that have worked well in normal market conditions could prove ineffective or detrimental during unusual conditions.

Operational risk In any market, but particularly in emerging markets, the Sub-Fund could suffer large losses from fraud, corruption, political or military actions, seizure of property or other adverse events.

ABS/MBS risk Mortgage or asset backed securities are subject to similar risks as other fixed income securities, and may also be subject to prepayment risk and higher levels of credit and liquidity risks.

Below Investment Grade Risk Lower rated or unrated securities may have a significantly greater risk of default than investment grade securities, can be more volatile, less liquid, and involve higher transaction costs.


