





### Maturity Breakdown (%)






The Sub-Fund seeks to achieve, over a medium term period, a mix of income and capital growth from an actively managed bond portfolio, whose carbon footprint, measured as carbon intensity, is at least 30% lower than that of the Bloomberg US Corporate Investment Grade index (the "Benchmark"). As a secondary 'extra-financial objective', the water intensity of the portfolio aims also at being at least 30% lower than the Benchmark.The Sub-Fund's objective to invest in lower carbon emissions intensive exposures than the Benchmark is not performed in view of achieving the long-term global warming objectives of the Paris Agreement.
