Global Bonds (the "Sub-Fund") is a sub-fund of Weisshorn Funds UCITS (the "Fund")

Class C (the "Class") - ISIN: LU1506617908

The Fund has appointed FundPartner Solutions (Europe) S.A. as management company.

Objectives and investment policy

The investment objective of the Sub-Fund is to seek long-term capital growth and income by investing in a debt portfolio of fixed/floating income instruments, Money Market Instruments, cash and cash equivalents and collective investment schemes ("UCIS") pursuing traditional strategies and to a lesser extent alternative strategies UCITS eligible funds.

The Sub-Fund is actively managed. The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

The investment manager will select debt securities or issuers to build a portfolio with an overall average credit quality of investment grade In order to reach its objective, the Sub-Fund will mainly invest in debt instruments (public and corporate issuers, short/long maturity bonds, fixed/variable rate securities, senior/subordinated debt, inflation-linked securities, perpetual bonds, investment grade/high yield bonds, convertible bonds), Money Market Instruments, cash and cash equivalents. These investments may be obtained:

- directly in the securities/asset classes mentioned above; and/or
- in UCIs having as main objective to invest in the above-mentioned asset classes.

The choice of investments will neither be limited by geographical area (including emerging markets), an economic sector, nor in a particular asset class, nor in currencies in which investments will be denominated. However, depending on financial market conditions, a particular focus can be placed in a single country and/or in a single economic sector and/or single asset class and/or in a single currency. On an ancillary basis, the Sub-Fund may invest in other eligible assets such as equity and equity related securities and UCIs.

To a lesser extent, the Sub-Fund may invest in:

- structured products as defined in the prospectus.
- UCITS eligible funds with alternative strategies ("equity long/short", "equity hedge", "relative value", "global macro", "event driven", ...).

All investments will be made in accordance with the provision set out under article 41 of the Law of 2010.

However, the Sub-Fund may invest directly in the assets listed below, subject to the following limits:

- Debt securities or issuers may have credit rating of all types (as detailed

in prospectus)

- The Investment Manager may invest in contingent convertible bonds up to 10% of the net assets.
- Total investments in funds will represent less than 50% of the net assets.
 Within this limit, alternative strategies UCITS eligible funds will not exceed 10% of the net assets.

For hedging and for any other purposes, the Sub-Fund may use financial derivative instruments within the limits and descriptions set out in the prospectus. The use of derivative instrument may increase leverage, imply additional costs and risks.

If the investment manager considers this to be in the best interest of the shareholders, on a temporary basis and for defensive purposes, the Sub-Fund may also hold, up to 100% of its net assets in liquidities, such as cash deposits, money market UCIs and Money Market Instruments.

Dealing Frequency

The net asset value for the Class is calculated on each bank business day in Luxembourg ("Calculation Day") on the basis of the prices of the preceding business day ("Valuation Day"). The cut-off time to submit subscriptions and /or redemption orders is 12 noon at the latest one business day before the relevant Valuation Day.

Distribution Policy

The Class is cumulative. No dividend will normally be distributed.

Currency

The currency of this Class is CHF.

This is a currency hedged class. It aims to reduce the impact on your investment of movements in the exchange rate between the Fund currency and the Class currency.

Minimum investment and/or holding requirement

For the Class, the minimum initial subscription amount is CHF 5,000.

Why is this Sub-Fund in this category?

The portfolio of this Sub-Fund consists essentially of debt securities issued worldwide with no particular focus on sectors. Hence, the risk/reward profile of the sub-fund should correspond to the medium risk category on the SRRI scale.

Are there any other particular Risks?

Risks that could affect fund performance and are not necessarily fully reflected in the risk and reward rating include:

 Liquidity risks: The Sub-Fund may invest part of its assets in less liquid securities. Those are securities that cannot easily be sold or exchanged for cash without a substantial loss in value in certain market conditions. Those securities also cannot be sold quickly because of a lack of ready and willing investors or speculators to purchase the asset.

- Counterparty risks: The Sub-Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Sub-Fund.
- Credit risks: The Sub-Fund invests a significant portion of its assets in debt securities. The issuers of these debt securities may become insolvent, which will mean that the securities will lose all or some of their value.
- Risks from the use of derivatives: The Sub-Fund may use financial derivatives instruments which may result in the Sub-Fund being leveraged and may result in material fluctuations in the value of the Sub-Fund. Leverage on certain types of transactions including derivatives may impair the sub-fund's liquidity, cause it to liquidate positions at unfavourable times or otherwise cause the Sub-Fund not to achieve its intended objective.

Leverage occurs when the economic exposure created by the use of derivatives is greater than the amount invested resulting in the Sub-Fund being exposed to a greater loss than the initial investment.

 Operational risks: The Sub-Fund may fall victim to fraud or criminal acts. It may suffer losses as a result of misunderstandings or mistakes by employees of the Management Company or by external third parties or may be damaged by external events, such as natural disasters.

The percentage of ongoing charges is based on the last year's expenses, ending 31/12/2021. This figure may vary from year to year. It excludes:


- Performance fees (if applicable)
