#### Investment focus

The fund's aim is to achieve capital growth in the long term. The Bellevue Healthcare Strategy fund actively invests in global healthcare companies with innovative business models. Its investment universe consists of biotechnology and pharma companies, medical technology and services companies as well as generics producers that are involved in the development, manufacturing or sale of products and services. Experienced sector specialists focus on profitable companies that have a well-established product portfolio. The fund invests top down in the four regions North America, Western Europe, Emerging Markets and Japan/Oceania. For each of these regions, the most attractive companies are determined based on quantitative and qualitative criteria. The fund seeks to outperform the MSCI World Healthcare Index. The fund takes ESG factors into consideration while implementing the aforementioned investment objectives.



#### Market review

MSCI World Healthcare underperformed MSCI World in March 2024 by 86 bps (MSCI World Healthcare +2.4% vs MSCI World +3.2%). The Bellevue Healthcare Strategy (Lux) Fund (I-shares: +1.6%) trailed (by 73 bps) its healthcare index benchmark. The underperformance was largely driven by stocks within the Emerging Market and Asia regions. From a macro perspective, US indicators over the last few months point to a "stronger-for-longer" scenario. The market seems to have digested the expectation of less aggressive future rate cuts (from 6 to 3 cuts in 2024 and yields increasing), with positive economic data helping to support equities. Along with a resilient consumer and GDP growth backdrop, we also saw strong earnings growth (SPX 4Q EPS was up ~9% yoy vs +4.3% consent heading into the quarter). Indeed, the most recent positive data point comes in the form of the ISM manufacturing index which increased to 50.3 in March from 47.8, the first print in expansionary territory since 2022. Overall we saw a broadening of performance across equities in March, in terms of sectors, subsector, style, and marketcapitalization.

Individual subsectors within the MSCI World Healthcare all performed solidly in the month. This was led by healthcare services (+2.9%) supported by the hospitals and drug distributors, followed by biotech (+2.8%) which saw continued support from momentum in M&A, life science tools (+2.5%) which rebounded from China fears, pharma (+2.3%) supported by some value-rebound, and finally a solid performance from medtech (+2.3%).

From a geographical point of view, the Europe (+3.6%) region within the MSCI World Health-care Index performed best, driven by Novo Nordisk, AstraZeneca, and Lonza. This was followed by another strong performance in the US (+2.3%), with Asia lagging (-2.8%). Within the fund, strong absolute performances (in USD) were reported during the month from Lonza (14.1%; China competition facing potential restrictions), Hygeia Healthcare (+8.4%; China equity market rebound), and Novo Nordisk (+7.9%; obesity theme). On the other hand, negative absolute performances were seen for Wuxi Biologics (-24.9%; US Biosecure Act bill plus weak guidance), Wuxi Apptec (-23.8%; US Biosecure Act bill plus weak guidance), and Asahi Intecc (-16.3%; profit decline risk).

### **General description**

The investment process for the Bellevue Healthcare Strategy Fund resembles the rulesbased investment process that Bellevue has successfully applied since 2007. In this approach, the 40 most attractive stocks in the healthcare sector worldwide are selected every six months. The Bellevue Healthcare team screens about 700 of the 4000 listed companies in the healthcare sector worldwide based on four quantitative criteria (PEG valuation, price/sales, sales growth and EBITDA/sales) and four qualitative criteria (assessing the company's management, product pipeline, operating risks and country-related risks). The ten most promising stocks from four different regions - Western Europe, North America, Japan/Australia and emerging markets - are selected. The maximum weighting of the region with the highest overall score, which is usually North America, is capped at 35% during the periodic rebalancing, which increases the emphasis given to emerging markets. Companies with rich valuations and low growth rates will rarely be selected for the portfolio. Mid cap stocks have typically represented 60-80% and the Asia region approximately onethird of the portfolio. Pharmaceutical stocks are clearly underweighted compared to the MSCI World Healthcare Index. Bellevue has applied this investment approach since April of 2007 and it is used to compile the Adamant Global Healthcare Index.

#### **Adamant Global Healthcare Index**

The index is the property of Bellevue Asset Management and it is calculated by Standard & Poor's on a daily basis in CHF, EUR and USD.


