

Market Commentary

Hedge funds gained +1.74% in February as measured by Credit Suisse Liquid Alternative Beta model performance. For the month, the Credit Suisse Liquid Alternative Beta Fund returned +1.73%. All three category models, Long/Short Equity, Event Driven, and Global Strategies, produced profits. Market expectations of a US soft landing faded as a brightening global growth outlook lent plausibility to the prospect of no landing, and instead, sustained above-trend growth. January's nonfarm payroll report showed that the US added 353,000 jobs in January, well above expectations. Central bankers sought to talk down the possibility of near-term rate cuts as they pointed to data dependence. Donald Trump consolidated his position as the GOP (The Republican Party) front-runner and proposed foreign policy shifts should he be reelected. Investors spent much of the month cheering Q4 2023 earnings reports, which, particularly in the Communications Services and Information Technology sectors, beat estimates and highlighted the fact that the impact of generative Al initiatives is exceeding already lofty expectations. Directional Equity and Market Neutral Size exposures supported the Long/Short Equity category model gains, which more than offset losses on short Industrial Sector and short Utilities Sector positioning. In the Event Driven category model, Event Oriented Equities, Credit, and Merger Arbitrage all generated gains. The Global Strategies category model benefitted from FX (Foreign Exchange) Directional, FX Carry, Trend, and Volatility Carry positioning, as well as its Event Driven factor exposure. During the program's monthly rebalancing, the Long/Short Equity category model increased Market Neutral Size short exposure and rotated its Sector exposure from short Industrial to short Utilities. The Event Driven category model reduced risk, dropping Merger Arbitrage exposure while increasing exposure to Credit. The Global Strategies category model increased Volatility Carry exposure and otherwise marginally refined p
