
#### Investment focus

The fund's aim is to achieve capital growth in the long term. The Bellevue Emerging Markets Healthcare fund actively invests in companies that have their registered office or carry out the majority of their economic activity in the healthcare markets of emerging countries. Its investment universe consists of generics producers, pharma and biotechnology companies, medical technology and services firms. Experienced sector specialists focus on profitable companies that have a well-established product portfolio. Investments are made based on fundamental research analysis. Stock selection is exclusively bottom-up, independent of benchmark weightings. The fund takes ESG factors into consideration while implementing the aforementioned investment objectives.



#### Market review

Global equities as measured by the MSCI World dropped about 3.7% in April in USD. Health-care stocks were unable to sidestep the negative trend and shed almost 4% of their value. For once, even the mega caps in the tech sector were unable to cushion the market's fall. The shares of Nvidia and Meta actually came under pressure due to profit-taking and some-what lower-than-expected quarterly results. Meanwhile investors continue to worry about the ongoing strength of the US labor market and stubbornly high inflation. At the end of last year consensus was expecting the Fed to cut its rates four times this year. Now only one cut is expected and there has even been talk of a rate hike. Then again, the more restrictive rate environment is having a growing impact on the US economy. Consumer sentiment and leading indicators are flagging a slowdown in economic activity on the horizon. It is quite possible that there will soon be chatter about stagflation. Emerging markets delivered a much better performance than their western counterparts. In contrast to the general trend, the MSCI Emerging Markets Index closed the month under review 0.4% higher. Healthcare stocks in the region closed 1.8% lower mom.

Innovent, one of the largest biotech companies in China, presented another convincing set of quarterly results. Its first-quarter sales surged 60% yoy and amounted to RMB 1.6 bn. Sales growth was no longer generated primarily by its PD-1 inhibitor Tyvyt, which was cheered by investors. Management efforts to diversify the company's operations seem to be increasingly paying off. Innovent is now expected to generate sales of more than RMB 7 bn for the full year. Innovent will present a raft of data from its antibody-drug conjugates (ADC) studies at this year's ASCO. The market is eagerly awaiting these readouts, especially since this class of therapeutic agents has recently demonstrated a high level of efficacy in other studies.

The quarterly results published by the Brazilian pharmaceutical company Hypera beat analyst expectations, especially at the bottom line, which showed 14% yoy growth. Market expectations were very conservative though. The respiratory disease segment is an important segment for Hypera and sales here were crimped by the record-high temperatures in Brazil. In addition, the company reduced its stockpiles at the expense of margins. Strict cost management more than compensated for the margin erosion though. Hypera remains a company with convincing quality and a strong market position and we slightly increased our shareholdings after the latest earnings announcement. The stock is currently trading at a historically low valuation.

Jordanian drug manufacturer Hikma also presented strong quarterly results. All three of the company's business segments showed good growth for the first three months of the year. Three new sterile injectable medicines were launched in the US. Its branded genercis segment benefited from strong demand for oncology drugs and for chronic disease treatments. Its generics segment also delivered good results thanks to strong demand and stable pricing.


Last month we added to our shareholdings of Mindray, Hansoh and Hypera and reduced our shareholdings of Sulaiman, Divis Laboratories, Cipla and Lupin. Positions in Sino Biopharmaceuticals and Oncoclinicas were exited.

## **Positioning & outlook**

The fastest growing countries in the world can be found in emerging markets and they contain more than half of the world's population. Asian emerging markets are also forecast to account for more than 50% of global GDP by 2050. It is known that the economic growth model of countries shifts from manufacturing to the services sector as household incomes rise. A growing middle class fuels demand for modern medicine. Healthcare ranks increasingly high on their wish list. Billions are being invested in infrastructure, technology and research to modernize the healthcare systems in emerging market countries. This is giving a greater swath of the population access to better healthcare. Meanwhile rapid population aging is also stoking demand for healthcare. In 30 years' time there will be 400 to 500 million people over 60 in China alone, and they will have a growing need for modern health services and medicines. Outside Asia, Brazil's rapidly expanding private-sector healthcare market offers a range of interesting investment opportunities. The quality and long waiting times of the country's public health system are no longer acceptable to many higher-income Brazilian households and they are increasingly embracing these new services offered by privatesector healthcare providers. Hospital chains embedded in a fully-integrated ecosystem are but one example of the beneficiaries of this structural change. The fund serves as a defensive vehicle for capturing the above-average growth potential emerging markets offer. It invests in the entire healthcare system value chain, from hospital chains, drug developers and device manufacturers to medical research specialists and digital health companies.
