#### Market review

Global equity markets surged in November, lifting the MSCI World by more than 9% mom in USD. Investors began to price in a soft economic landing in the US, bolstering a Goldilocks scenario where inflation has been tamed and the Fed can start to cut interest rates again from mid-2024. Record-low unemployment rates across the US, coupled with the hefty pay raises labor unions have recently secured, could, however, set wage-price spirals in motion. Against this backdrop, healthcare stocks in emerging markets also had a good run in November, closing almost 6% higher mom.

The FDA announced that it had launched an investigation into the risk of T-cell malignancies in patients treated with currently approved BCMA or CD19-directed autologous CAR T-cell therapies. The FDA said it would be evaluating the need for regulatory action, but also that the overall benefit of these treatments continued to outweigh the potential risks for their approved uses in various oncological indications (lymphoma, myeloma, leukemia). It's possible that FDA is focusing its investigation on treatments in non-oncology settings where the risk tolerance for developing cancer is lower, for example in autoimmune diseases. Legend Biotech, the market leader for multiple myeloma cell therapy, was among the companies that traded lower in the wake of the FDA announcement. We are nevertheless confident that Carvykti's superior effectiveness in treating this incurable disease will remain a decisive factor.

Investors have urged Celltrion Group to simplify its complicated and intransparent corporate structure for many years. Those calls are finally being heeded. At the end of the proposed merger process, only one Celltrion stock will be listed on the stock exchange and investor attention will then be more focused on the biosimilar giant's business fundamentals. High hopes have been pinned on Celltrion's subcutaneous formulation of its infliximab (Remicade) biosimilar, which has already been successfully launched in Europe. It will be launched in the US as a new drug around the middle of 2024 at a list price of USD 26 000 a year.

New positions in Rainbow Children Medicare, Hansoh and Sulaiman were opened last month. Existing positions in Oncoclinicas and Cipla were also topped up. Shareholdings of AK Medical, Wuxi Apptec, Tigermed and Apollo Hospitals were reduced and Dr. Sulaiman and Divi's Laboratories were removed from the portfolio.

#### **Positioning & outlook**

The fastest growing countries in the world can be found in emerging markets and they contain more than half of the world's population. Asian emerging markets are also forecast to account for more than 50% of global GDP by 2050. It is known that the economic growth model of countries shifts from manufacturing to the services sector as household incomes rise. A growing middle class fuels demand for modern medicine. Healthcare ranks increasingly high on their wish list. Billions are being invested in infrastructure, technology and research to modernize the healthcare systems in emerging market countries. This is giving a greater swath of the population access to better healthcare. Meanwhile rapid population aging is also stoking demand for healthcare. In 30 years' time there will be 400 to 500 million people over 60 in China alone, and they will have a growing need for modern health services and medicines. Outside Asia, Brazil's rapidly expanding private-sector healthcare market offers a range of interesting investment opportunities. The quality and long waiting times of the country's public health system are no longer acceptable to many higher-income Brazilian households and they are increasingly embracing these new services offered by privatesector healthcare providers. Hospital chains embedded in a fully-integrated ecosystem are but one example of the beneficiaries of this structural change. The fund serves as a defensive vehicle for capturing the above-average growth potential emerging markets offer. It invests in the entire healthcare system value chain, from hospital chains, drug developers and device manufacturers to medical research specialists and digital health companies.
