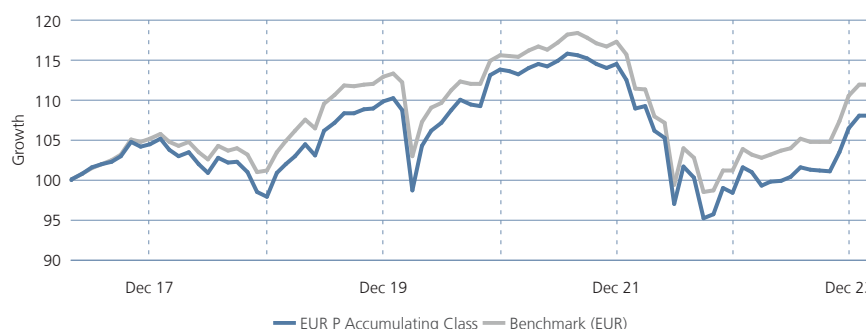

RISK CONSIDERATIONS
