## Objectives and Investment Policy

**Investment objective:** The Sub-Fund's investment objective, is to grow net asset value by investing in companies registered predominantly in Asean Countries.

**Benchmark index:** The Sub-Fund's performance may be compared to the MSCI AC South East Asia USD Index, calculated net dividends reinvested.

The benchmark index of the Sub-Fund serves only for comparison purposes. The Sub-Fund is actively managed.

**Investment policy:** The Sub-Fund's investment strategy involves actively investing in equities of companies headquartered or with main business in the Asean Countries or in equities listed in Asean Countries. The Investment Manager selects, on a discretionary basis, companies which it considers to offer good medium/long term earnings as well as growth potential, using a fundamentals approach to the companies, especially the quality of their financial structure, their competitive positioning in the market, the quality of their management, their strategic orientation and their policy of information to shareholders.

The Sub-Fund's net assets will be exposed to Asean Countries equity markets including, with a flexible allocation, large caps, mid-caps, small caps and micro caps companies. Due to the investment strategy, the Sub-Fund will invest up to 110% of its net assets in Emerging Markets within the Asean Countries. In addition, the Sub-Fund may be exposed to currency risk of up to 110% of its total net assets.

Based on the Investment Manager's expectations of trends on the equity markets, the Sub-Fund may invest up to 40% of its net assets in debt securities and Money Market Instruments of public or equivalent issuers or private issuers traded on international markets, at fixed and/or variable rates, without restriction as to geographical area or maturity.

The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities.

Subject to a limit of 100% of its net assets, the Sub-Fund may invest in OTC Derivatives or financial contracts traded on a Regulated Market or Other Regulated Market in order to conclude currency forward contracts or currency swaps. All these instruments are used solely for share Class hedging purposes.

The Sub-Fund may also invest up to 100% of its net assets in equities with embedded derivatives consisting of warrants and certificates, including global depositary receipts.

**The recommended minimum investment period is 5 years.**

**Frequency of share buying or selling:** Every Luxembourg and France bank business day and any other day on which the Hong Kong and French financial markets are open, except for Good Friday and 24 December (Christmas Eve) for orders received by the transfer agent no later than 4:30 pm (Luxembourg time) on the business day before Valuation Day.

**Income allocation:** Accumulation

### Significant risks not taken into account in this indicator:

**Credit risk** : When a significant level of investment is made in debt securities.

**Liquidity risk** : The markets for some securities and instruments may have limited liquidity. This limited liquidity could be a disadvantage to the Sub-Fund, both in the realisation of the prices quoted and the execution of orders at desired prices.

**Impact of techniques such as derivative contracts** : The use of derivatives instruments can infer a decrease of the asset more significant than the decrease of the invested underlying assets or markets.

**Counterparty risk** : Where a Fund is backed by collateral or has significant investment exposure through contracts with a third party.

**Operational risk** : The Sub-Fund may suffer losses due to the failure of operational processes, including those related to the safekeeping of assets.

The occurrence of any of these risks may negatively impact the net asset value.

<b>Performance fee</b> The performance fee is set at 15% and is calculated by comparing the Sub-fund's share performance with that of an indexed reference asset, over the relevant Calculation Period. This fee is due even in the case of a reduction in the Net Asset Value provided that the decrease in Net Asset Value is less than the decrease in the benchmark index. The calculation method is described in the prospectus (outperformance model2).	

Charges and fees are paid to cover the operating costs of the Sub-Fund, including the cost of marketing and distributing share classes. These costs reduce the potential growth of your investment.

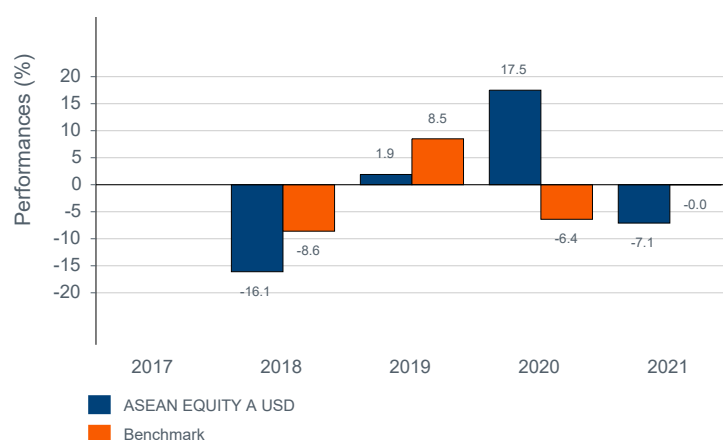
Investors may obtain the actual amount of entry and exit charges from their advisor or distributor. In certain cases you might pay less.

The ongoing charges figure is based on the last year's expenses, for the year ending in December 2021. This figure may vary from year to year. It excludes performance fees and intermediary fees except entry and exit charges paid by the Sub-Fund when buying or selling units and/or shares of another UCI.

The performance fee paid for the preceding exercise closing on December 2021 represents 0.15% of net assets.
