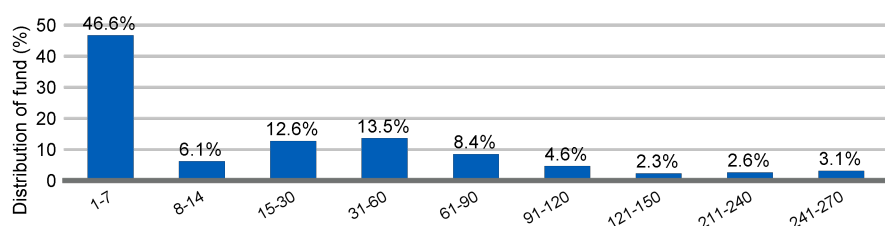
Investment Objective

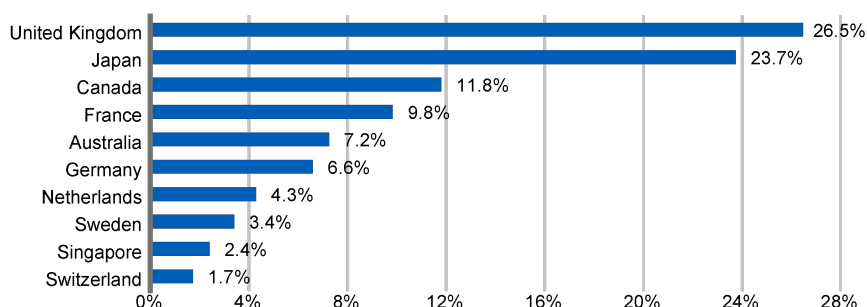

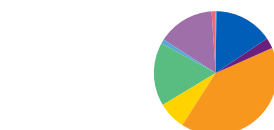

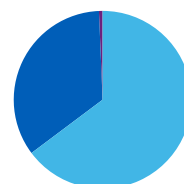

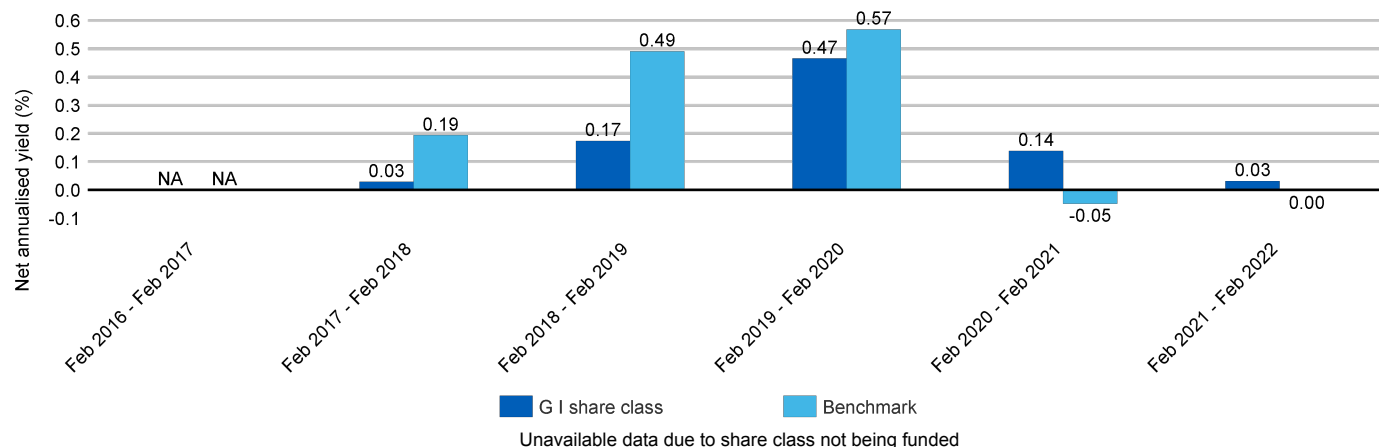

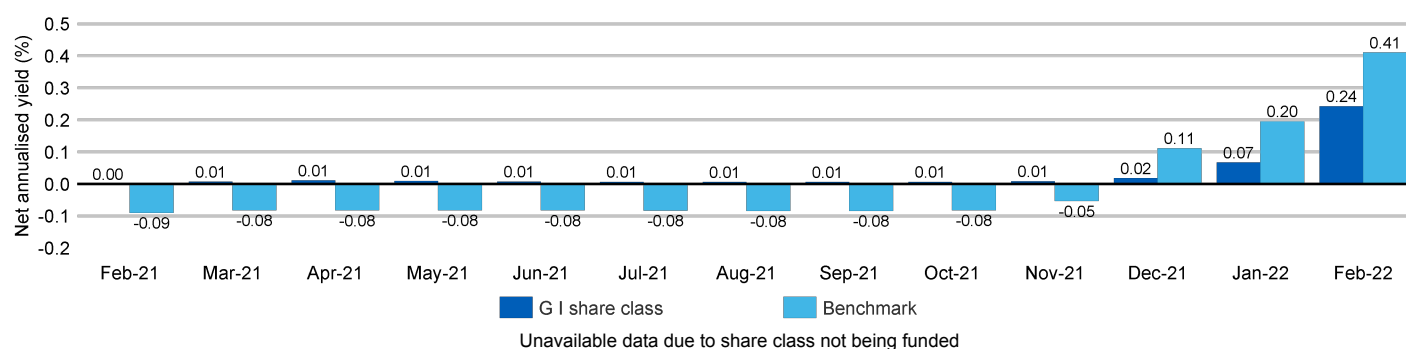

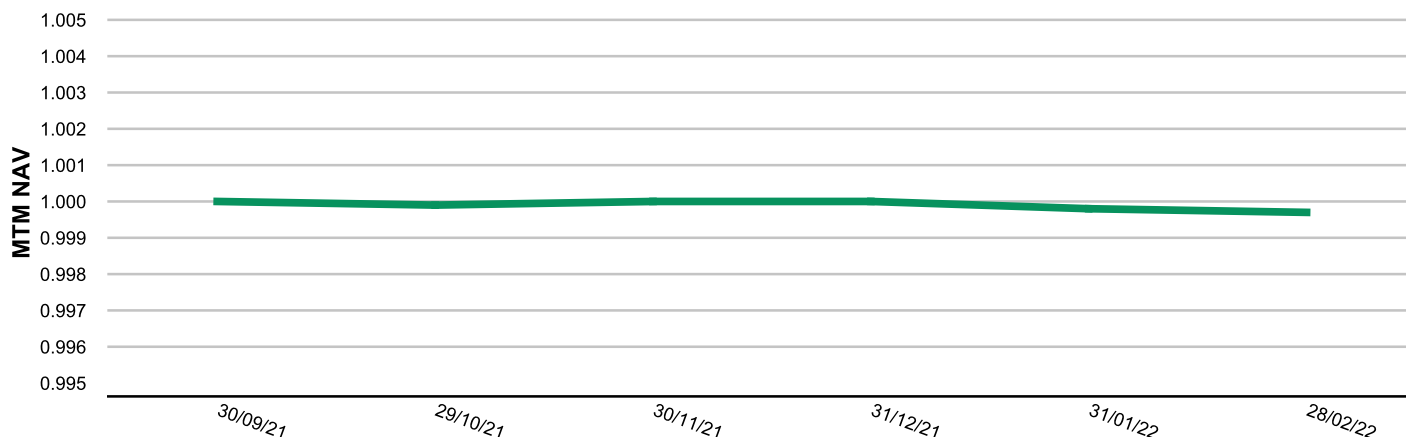
