#### Investment focus

The fund's aim is to achieve capital growth in the long term. The Bellevue Healthcare Strategy fund invests in global healthcare companies with innovative business models. Its investment universe consists of biotechnology and pharma companies, medical technology and services companies as well as generics producers that are involved in the development, manufacturing or sale of products and services. Experienced sector specialists focus on profitable companies that have a well-established product portfolio. The fund invests top down in the four regions North America, Western Europe, Emerging Markets and Japan/Oceania. For each of these regions, the most attractive companies are determined based on quantitative and qualitative criteria. The fund seeks to outperform the MSCI World Healthcare Index. The fund takes ESG factors into consideration while implementing the aforementioned investment objectives.



#### **Market review**

MSCI World Healthcare underperformed MSCI World in December 2023 by 49 bps (MSCI World Healthcare +4.4% vs. MSCI World +4.9%). The Bellevue Healthcare Strategy (Lux) Fund (I-shares: +2.9%, in USD) trailed (by 151 bps) its healthcare index benchmark net-offees. Overall, the fund's exposure to Chinese healthcare stocks proved to be a headwind through the month.

Following easing inflation data in November, US Fed dot-plots and commentary at the December FOMC meeting pointed to rate cuts in 2024. This provided continued fuel for the risk-on market rally in December. As such, the more defensive healthcare sector was unable to keep-up with the performance of more cyclical sectors such as industrials (7.6%) and materials (6.9%).

Turning to individual subsectors within the MSCI World Healthcare, biotech (+8.9%) was by far the most best performer in the month supported by a risk-on market sentiment as the Fed signalled potential rate cuts, and a number of M&A deals announced. This is followed by life science tools (+8.4%), healthcare IT (+8.2%), medtech (+6.7%), pharma (+2.7%) and healthcare services (+0.4%). From a geographical point of view, within the MSCI World Healthcare the regions US (+4.4%) and Europe (+4.3%) performed roughly equally well. In contrast, the Asia (+1.5%) ended the period in positive territory, but comparatively weaker. The weak Asia performance was a headwind for the fund's performance.

On a stock-specific basis, strong absolute performances (in USD) were reported during the month from UCB (+17.8%; strong Bimzelx prescription launch), Straumann (+16.6%; cyclical rally as Fed pivot expectations raise), and Evotec (+16.3%; supportive macro and new partnership announcements). Conversely, negative absolute performances were seen for Wuxi Biologics (-31.9%; guidance cut), Hygeia Healthcare (-26.6%; guidance cut), and Argenx (-15.6%; Phase III trial failure in pemphigus vulgaris and pemphigus foliaceus).

#### **General description**

The investment process for the Bellevue Healthcare Strategy Fund resembles the rulesbased investment process that Bellevue has successfully applied since 2007. In this approach, the 40 most attractive stocks in the healthcare sector worldwide are selected every six months. The Bellevue Healthcare team screens about 700 of the 4000 listed companies in the healthcare sector worldwide based on four quantitative criteria (PEG valuation, price/sales, sales growth and EBITDA/sales) and four qualitative criteria (assessing the company's management, product pipeline, operating risks and country-related risks). The ten most promising stocks from four different regions - Western Europe, North America, Japan/Australia and emerging markets - are selected. The maximum weighting of the region with the highest overall score, which is usually North America, is capped at 35% during the periodic rebalancing, which increases the emphasis given to emerging markets. Companies with rich valuations and low growth rates will rarely be selected for the portfolio. Mid cap stocks have typically represented 60-80% and the Asia region approximately onethird of the portfolio. Pharmaceutical stocks are clearly underweighted compared to the MSCI World Healthcare Index. Bellevue has applied this investment approach since April of 2007 and it is used to compile the Adamant Global Healthcare Index.

## **Adamant Global Healthcare Index**

The index is the property of Bellevue Asset Management and it is calculated by Standard & Poor's on a daily basis in CHF, EUR and USD.




