FUND OBJECTIVE

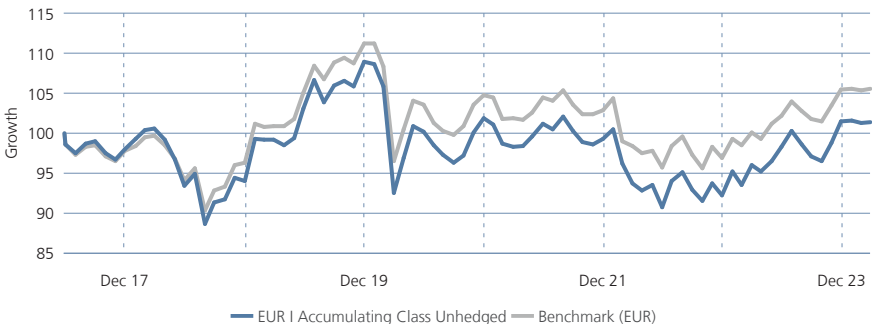

RISK CONSIDERATIONS
