## KEY INVESTOR INFORMATION

This document provides you with key investor information about this Fund. It is not marketing material. ### UBAM - EM Responsible Sovereign Bond, a sub-fund of UBAM

UBAM is managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow capital and generate income by investing primarily in Emerging or Frontier countries bonds in hard currencies such as (but not limited to) EUR or USD issued by Public Authorities or quasi sovereign entities. Exposure can be direct or made through derivatives such as CDS (Credit Default Swap).

The Fund is actively managed and invests a minimum of 2/3 of its net assets in products/issuers with a minimum rating of B- (S&P or Fitch), B3 (Moody's) or an equivalent rating by another rating agency and up to 1/3 of its net assets in products/issuers with a lower rating.

The Fund may invest up to 15% of its net assets in non-rated products/issuers.

The Fund aims notably to promote social outcomes such as sovereign's human rights record, labour standards, education system, health care, demographics.

The investment strategy relies on credit and macroeconomic assessment and Environmental, Social and Governance (ESG) analysis.

The sustainable objective of the Fund is to provide a higher ESG Quality score than the JP Morgan CEMBI Diversified Index ("the Benchmark") as measured using the MSCI ESG research.

The investment process includes internal and external ESG analysis and a proprietary ESG sovereign scoring model, which combines historical ESG data and forward-looking sentiment to rank countries in terms of their relative ESG quality.

The investment process includes a first phase of investment universe filtering and a second phase of ESG bottom-up research.

The first phase consists in selecting issuers with sound ESG quality and avoids controversial business activities as well as companies in breach of international norms (norms-based screening).

The second phase integrates ESG considerations into the issuers' qualitative credit assessment conducted by the Investment Manager. This analysis relies on different sources of information and data as well as external ESG data and scoring providers.

The ESG analysis covers at least 90% of the Fund's portfolio.

The Fund uses the Benchmark for performance objective. This Benchmark is representative of the investment universe but not representative of the risk profile of the Fund. The performance of the Fund is likely to be significantly different from that of the Benchmark because the Investment Manager has significant discretion to deviate from its securities and weighting.

The Benchmark is not aligned with the environmental and/or social characteristics promoted by the Fund.

The Fund may invest its net assets up to:

- 100% in High yield. *This exposure can be increased up to 120% through derivatives*
- 100% in Emerging or Frontier countries (including China through Bond Connect up to 20%). *This exposure can be increased up to 120% through derivatives*
- 20% in corporate bonds
- 20% in Contingent Convertible bonds (CoCos)

Overall, up to 20% of the Fund's investments may be carried out in Emerging countries' currencies.

High yield bonds are issued by entities whose activity is more sensitive to the economic cycle and pay higher interest. The return on such securities, in the same way as their level of risk, is therefore higher than traditional bond products.

The Fund's base currency is USD.

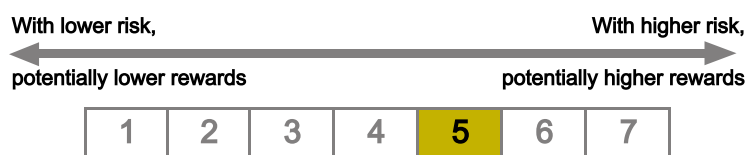
Any income received by the Fund is reinvested (capitalisation share class).

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive market is closed: United States (US).

### Risk and reward profile

Significant risk(s) for the Fund not taken into account in this indicator include the following:

**Bond Connect risk:** Investment through Bond Connect is subject to additional risks mainly regulatory and tax.

**Counterparty risk:** The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honour its contractual obligations. This may result in a financial loss for the Fund.

**Credit risk:** The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this

happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

**Currency risk:** The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

**Emerging countries risk:** The Fund invests in overseas countries which carry a higher risk than investing in larger established countries. Investments in Emerging countries are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in Emerging countries rather than more developed countries may encounter difficulties when buying and selling investments. Emerging countries are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

**ESG and Sustainability risk:** It may result in a material negative impact on the value of an investment and performance of the Fund. Assessment of sustainability risks is complex and requires subjective judgments, which may be based on data which is difficult to obtain and/or incomplete, estimated, out of date or otherwise materially inaccurate. All or part of said data may come/originate from third parties.

**Liquidity risk:** Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

**Political and Social risk:** Investments in China will be sensitive to any political, social and diplomatic developments which may take place in or in relation to China. Investors should note that any change in the policies of China may adversely impact on the securities.

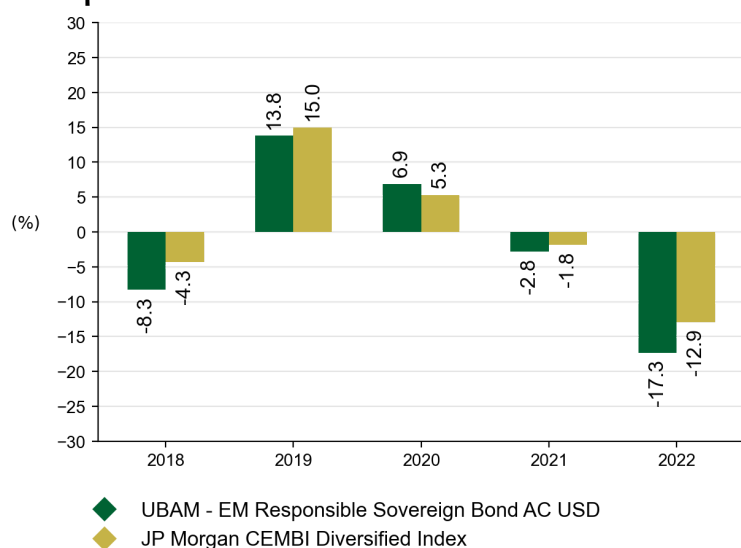
