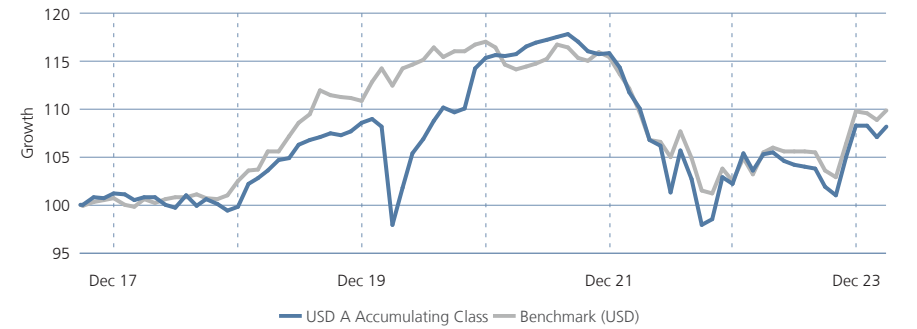

RISK CONSIDERATIONS
